

MINUTES OF REGULAR COUNCIL MEETING HELD OCTOBER 3, 1978.

COUNCIL MET IN REGULAR SESSION, MAYOR MURRAY PRESIDING.

COUNCIL MEMBERS PRESENT: FANCHER, REED, BANKSON, DAVIES, PIERCEFIELD, HOPKINS, WADE, ALLEN, HAYES, AND MEANS.

ALL COUNCIL MEMBERS WERE PRESENT.

MOTION WAS MADE BY WADE AND SECONDED BY HOPKINS THAT THE MINUTES OF REGULAR COUNCIL MEETING HELD SEPTEMBER 19, 1978, BE AMENDED AND PLACED ON FILE. MOTION CARRIED.

MOTION WAS MADE BY REED TO ACCEPT A LETTER OF INTENT UP TO ONE MILLION FIVE HUNDRED DOLLARS IN INDUSTRIAL REVENUE BONDS. MOTION DIED FOR A LACK OF A SECOND.

MOTION WAS MADE BY BANKSON AND SECONDED BY HOPKINS THAT THE ASSEMBLY OF GOD CHURCH BE ALLOWED THE USE OF THE COMMUNITY ROOM SUNDAY, NOVEMBER 26, 1978, FROM APPROXIMATELY 10:30 a.m. TO 6.00 p.m. FOR DINNER. MOTION CARRIED.

MOTION WAS MADE BY BANKSON AND SECONDED BY HAYES THAT MIKE HALL, RICHARD MONTEA AND REX GANDY BE ALLOWED TO ATTEND THE WATER AND WASTE WATER DISTRICT SCHOOL OCTOBER 11 & 12 WITH THE COST OF \$5.00 A DAY PER MAN. MOTION CARRIED.

MOTION WAS MADE BY PIERCEFIELD AND SECONDED BY DAVIES TO TABLE THE PURCHASING OF A TRACTOR FOR THE CEMETERY DEPARTMENT. MOTION CARRIED.

MOTION WAS MADE BY WADE AND SECONDED BY FANCHER THAT THE CITY TAKE STEPS TOWARD INSTALLATION OF WATER LINES FOR DAVID JONES. (1) ABSTAINED: MEANS.

MOTION WAS MADE BY WADE AND SECONDED BY PIERCEFIELD TO GRANT DAVID JONES A LICENSE FOR A MOBIL HOME PARK PENDING HIS COMPLIANCE WITH CITY ORDINANCES.

MOTION WAS MADE BY BANKSON AND SECONDED BY HOPKINS THAT WINTER UNIFORMS FOR THE NEW OFFICERS IN THE AMOUNT OF \$330.00 BE TAKEN OUT OF THE REVENUE SHARING FUND. MOTION CARRIED.

MOTION WAS MADE BY WADE AND SECONDED BY DAVIES THAT THE FIRE DEPARTMENT BE ALLOWED TO PURCHASE A PUMP FOR THE TANK TRUCK AT A COST OF \$1,000.00 TO BE PAID FROM THE FIRE BUDGET. MOTION CARRIED.

MOTION WAS MADE BY WADE AND SECONDED BY ALLEN THAT A \$20.00 DEPOSIT BE MADE FOR THE USE OF THE COMMUNITY ROOM OTHER THAN GOVERNMENTAL FUNCTIONS WITH THE \$20.00 TO BE REFUNDED UPON INSPECTION OF THE COMMUNITY ROOM BY THE JANITOR. MOTION CARRIED.

MOTION WAS MADE BY BANKSON AND SECONDED BY REED THAT THOMAS CUSACK BE PAID \$75.00 FOR DISCUSSION OF QUARTERLY REPORT AND THAT HARTLEY INSURANCE AGENCY BE PAID \$589.00 FOR THE INSTITUTIONAL POLICY INSURANCE. MOTION CARRIED.

MOTION WAS MADE BY DAVIES AND SECONDED BY HOPKINS THAT ORDINANCE 997 BE ABOLISHED AND ORDINANCE 998 REPLACE THE ORDINANCE. (5) YEAS: WADE, BANKSON, REED, HOPKINS, DAVIES
 (5) NAYS: ALLEN, HAYES, FANCHER, MEANS, PIERCEFIELD.

MAYOR MURRAY BROKE THE TIE WITH A YEA VOTE TO REPEAL ORDINANCE 997. MOTION CARRIED.

MOTION WAS MADE BY PIERCEFIELD AND SECONDED BY REED THAT A RESOLUTION BE PASSED TO PUT THE NUDE DANCERS' MATTER ON THE BALLOT IN NOVEMBER TO SEE WHAT THE MAJORITY OF THE PEOPLE THINK ABOUT THE ISSUE. MOTION CARRIED.

MOTION WAS MADE BY BANKSON AND SECONDED BY REED THAT THE CITY ADVERTISE FOR APPLICATIONS TO SERVE ON THE PLANNING & ZONING COMMISSION. MOTION CARRIED.

MOTION WAS MADE BY BANKSON AND SECONDED BY WADE THAT CDBG 78-19 IN THE AMOUNT OF \$11,658.99 AND PAYROLL ORDINANCE 78-21 IN THE AMOUNT OF \$9,256.94 be APPROVED FOR PAYMENT. MOTION CARRIED.

MOTION WAS MADE BY PIERCEFIELD AND SECONDED BY MEANS TO ADJOURN. MOTION CARRIED BY STANDING.
