

MINUTES OF REGULAR COUNCIL MEETING HELD OCTOBER 4, 1977.

COUNCIL MET IN REGULAR SESSION, MAYOR MURRAY PRESIDING.

COUNCIL MEMBERS PRESENT:

WARD, REED, BANKSON, DAVIES, MURRAY, HOPKINS, ALLEN, AVICOLA, MEANS, WADE.

ALL COUNCIL MEMBERS WERE PRESENT.

MOTION WAS MADE BY REED AND SECONDED BY AVICOLA THAT THE MINUTES OF REGULAR COUNCIL MEETING HELD SEPTEMBER 20 BE APPROVED AND PLACED ON FILE. MOTION CARRIED.

MAYOR MURRAY APPOINTED A COMMITTEE OF AVICOLA, BANKSON, AND DAVIES TO MEET WITH THE SCOUT MASTER FOR PERMISSION FOR THE RAINBOW GIRLS TO USE THE SCOUT HOUSE AT SCHERMERHORN PARK ON OCTOBER 29.

MAYOR MURRAY PRESENTED THE COUNCIL WITH BIDS FOR REHABILITATION FOR THE RESIDENCE AT 710 CHICAGO, 12TH & BAKER, 1504 LINCOLN DRIVE, 1103 BAKER AND THE FOLLOWING RESIDENCE FOR DEMOLITION: 215 LILY PLACE, 908 N. HENNING, 914 N. HENNING, 1207 N. FOREST, 1914 GALENA AVENUE, AND 1504 GALENA AVENUE. MAYOR MURRAY ASK THE COMMUNITY DEVELOPMENT COMMITTEE AND MARY ANN TO BRING RECOMMENDATION ON THE BIDS TO THE NEXT COUNCIL MEETING.

MOTION WAS MADE BY DAVIES AND SECONDED BY HOPKINS THAT THE FORCE ACCOUNT OF C.D.B.G. BE CLOSED. MOTION CARRIED.

MOTION WAS MADE BY AVICOLA AND SECONDED BY DAVIES THAT COMMUNITY DEVELOPMENT EMPLOYEES WITH SIX MONTHS OR MORE EMPLOYMENT BE GRANTED VACATION. MOTION CARRIED.

MOTION WAS MADE BY DAVIES AND SECONDED BY AVICOLA TO DONATE \$300.00 TO THE PEE WEE AND MIDGET FOOTBALL LEAGUE FROM THE WATER FUND. MOTION CARRIED.

MOTION WAS MADE BY AVICOLA AND SECONDED BY BANKSON THAT SELLS CONSTRUCTION BE PAID ESTIMATE #5 IN THE AMOUNT OF \$83,520.00 ON THE NEW COMPLEX. MOTION CARRIED.

MAYOR MURRAY PRESENTED THE NAME OF ROBERT TURNER FOR CONFIRMATION AS A AUXILLERY POLICE.

MOTION WAS MADE BY AVICOLA AND SECONDED BY MURRAY THAT ROBERT TURNER BE CONFIRMED AS AUXILLERY POLICE. MOTION CARRIED.

MOTION WAS MADE BY HOPKINS AND SECONDED BY BANKSON THAT HARVEY JONES BE GRANTED TWO WEEKS VACATION FROM OCTOBER 24 TO NOVEMBER 7. MOTION CARRIED.

MOTION WAS MADE BY DAVIES AND SECONDED BY AVICOLA THAT A WATER LINE BE INSTALLED TO THE RUBY JENKINS PROPERTY AT A COST OF APPROXIMATELY \$352.33 TO BE PAID FROM THE WATER FUND. MOTION CARRIED.

MOTION WAS MADE BY DAVIES AND SECONDED BY AVICOLA THAT THE MUNICIPAL JUDGE AND CITY ATTORNEY ATTEND SCHOOL AT WICHITA, OCTOBER 11 WITH EXPENSES TO BE REIMBURSED BY THE CITY. MOTION CARRIED.

MOTION WAS MADE BY AVICOLA AND SECONDED BY MURRAY THAT THE CITY ENTER INTO CONTRACT WITH C. E. T. A. ON EMPLOYMENT OF LEROY LAKE WITH CITY PAYING 50% OF SALARY AND C.E.T.A. PAYING 50% FOR A MINIMUM OF SIX MONTHS. MOTION CARRIED.

MOTION WAS MADE BY HOPKINS AND SECONDED BY AVICOLA THAT JANELLE DONNA BE RETAINED BY THE CITY FOR A PERIOD OF ONE MONTH. MOTION CARRIED.

MAYOR MURRAY PRESENTED THE NAMES OF REX HOPKINS AND DANNY WEBB AS A PATROLMAN AND ASK THAT THE COUNCIL VOTE BY BALLOT. THE COUNT OF THE BALLOTS WAS WEBB (9) HOPKINS (1).

MOTION WAS MADE BY AVICOLA AND SECONDED BY MURRAY THAT DANNY WEBB BE CONFIRMED AS PATROLMAN. MOTION CARRIED.

MAYOR MURRAY PRESENTED THE COUNCIL WITH TWO NEW OCCUPATIONAL LICENSES REQUEST OF CANDY CORRAL, 710 MAIN, AND CENTRAL REBUILDERS, 919 E. 7TH.

MOTION WAS MADE BY AVICOLA AND SECONDED BY DAVIES THAT THE ABOVE LICENSES BY GRANTED. MOTION CARRIED.

MAYOR MURRAY PRESENTED THE NAME OF DON LA PANNE FOR CONFIRMATION TO REPLACE DENNIS CURE ON THE HOUSING AUTHORITY BOARD.

MOTION WAS MADE BY DAVIES AND SECONDED BY AVICOLA THAT DON LA PANNE BE CONFIRMED AS A MEMBER OF THE HOUSING AUTHORITY BOARD. MOTION CARRIED.

MOTION WAS MADE BY DAVIES AND SECONDED BY AVICOLA THAT PAYROLL ORDINANCE 77-21 IN THE AMOUNT OF \$6,393.85 AND C. D. B. G. ORDINANCE 77-19 IN THE AMOUNT OF \$9,996.09 BE APPROVED FOR PAYMENT. MOTION CARRIED.

MOTION WAS MADE BY BANKSON AND SECONDED BY AVICOLA THAT THE POLICE REPORT FOR SEPTEMBER IN THE AMOUNT OF \$1,018.00 BE APPROVED AND PLACED ON FILE. MOTION CARRIED.

MOTION WAS MADE BY BANKSON AND SECONDED BY AVICOLA THAT THE STOCK MARSHAL'S REPORT FOR SEPTEMBER IN THE AMOUNT OF \$32.00 BE ACCEPTED AND PLACED ON FILE. MOTION CARRIED.

MOTION WAS MADE BY BANKSON AND SECONDED BY HOPKINS THAT STEVEN PITTMAN BE GRANTED ONE WEEKS VACATION PAY IN LIEU OF VACATION. MOTION CARRIED.

MOTION WAS MADE BY DAVIES AND SECONDED BY AVICOLA THAT THE STOCK MARSHAL DO NECESSARY REPAIRS TO DOG POUND NOT TO EXCEED \$100.00. MOTION CARRIED.

MOTION WAS MADE BY DAVIES AND SECONDED BY MEANS THAT THE POLICE CHIEF BE ALLOWED TO SPEND \$30.00 PER MONTH FOR MAINTENANCE AND SERVICE WORK ON POLICE CARS WITHOUT PURCHASE ORDER BEING OBTAINED BEFORE WORK IS DONE. MOTION CARRIED.

MOTION WAS MADE BY BANKSON AND SECONDED BY DAVIES TO AUTHORIZE THE CONTINUANCE OF THE JUNIOR PATROL. MOTION CARRIED.

MOTION WAS MADE BY DAVIES AND SECONDED BY AVICOLA THAT THE PETITION PROTESTING PLACING THE PICK UP SERVICE ON THE WATER BILL BE ACCEPTED AND PLACED ON FILE IN CITY CLERKS OFFICE WITH NO ACTION TAKEN. MOTION CARRIED.

COUNCIL MEMBER WARD PRESENTED THE COUNCIL WITH PICTURES AND ADDRESSES OF RESIDENCE WITH RECOMMENDATION OF DEMOLITION TO BE PAID FROM C.D.B.G. FUNDS.

MOTION WAS MADE BY DAVIES AND SECONDED BY AVICOLA THAT THE MEETING ADJOURN. MOTION CARRIED.
