MINUTES OF GALENA CITY COUNCIL MEETING OCTOBER 18, 1983

CALL TO ORDER:

The Regular Meeting of the City Council of the City of Galena was called to order by Mayor James Bankson at 7:00 P.M., in the Council Chambers on Tuesday, October 18, 1983.

ROLL CALL:

Roll call indicated the following councilmembers present: Gibson, King, Hayes, Little, Anderson, J. Watkins, Colgrove, R. Watkins, Allen. Absent: Means.

MINUTES:

Moved by Anderson, seconded by Hayes, to approve and place on file the minutes of the Regular Meeting on October 4, 1983. Motion declared carried. (J. Watkins abstained)

CEREAL MALT BEVERAGE PETITION: Mayor Bankson read a letter from County Clerk, Maurice Soper, saying the petition presented to city clerk on Charter Ord. #5 raising cereal malt beverage license fees was non-valid due to the format and an insufficien number of legally qualified electors, as required by K.S.A. 25-3602 and K.S.A. 25-3604.

Moved by J. Watkins, seconded by R. Watkins, to approved another Charter Ord. which would repeal Charter Ord. #5 which would raise cereal malt beverage license fees. Roll call vote indicated:

Motion declared failed.

CLERK SCHOOL:

Moved by Little, seconded by Colgrove, to allow city clerk, Barbara Wilkins, to attend the certification institute in Lawrence, Ks. the week of Nov. 13-18, 1983 with expensed to be paid by the City. Motion declared carried.

OF LIBRARY:

Moved by Little, seconded by R. Watkins, to place a flood light with a timer on it in front of the library entrance. Motion declared carried.

MATER LINE REPLACE-MENT - 9TH & GALENA AVE.: Moved by Little, seconded by R. Watkins, to replace a water line and install a fire hydrant between 8th & 9th on Galena Avenue at a approximate cost of \$1,048.00 with line coming out of the Special Water Fund. Motion declared carried.

DAV FLAG PRESENTATION:

Chapter 40 of the Disabled American Veterans, presented the city with an American and Kansas state flags. Mayor James Bankson accepted the American flag while Chief of Police, Bill Lyerla accepted the State flag.

NUISANCE - 19th & DEWEY ROADWAY:

City Inspector, Gene Porter, informed the council of tall weeds and grass on property owened by Wilbur Moody at 19th & Dewey on the roadway. Due to a situation last year concerning who would pay to have the roadway cut, Mr. Porter wanted to know what proceedure to take concerning the property. He was informed to send a regular 10 day notice as on all other nuisance.

CONDEMNATIONS:

City Inspector, Gene Porter, informed the council of a request from property owner at 301 Joplin, who wanted her garage condemned and removed by the city. The City will follow the regular condemnation process to remove the garage.

Building located at 3rd and Main had some bricks falling. The owner as obtained a demolition permit to remove the top floor and will bring the lower level up to code. Gene Porter is working with him on this. Page Two

HUNTER SAFETY COURSE:

Moved by Little, seconded by Hayes, to have the Police Chief conduct a one day Hunter Safety Course on Saturday November 12 consisting of 8 hours. Motion declared carried.

COMMITTEE REPORTS:

Sanitation: Committee requested that the sanitation truck driver submit a list of what alleys are deadend and ones that are rough to use because of tall weeds and grass.

WATER: Water report for September showed 14,396,900 gals.pumped and 10,729,140 gals. sold indicating a water loss of 25%.

POLICE: The City Court will be held on 10:00 a.m. Saturday mornings from now on in compliance with our City ordinance.

APPROPRIATIONS 83-23:

Moved by J. Watkins, seconded by Gibson, to approve appropriations 83-23 in the amount of \$26,602.69. Motion declared carried.

PAYROLL 83-23:

Moved by J. Watkins, seconded by R. Watkins, to approve Payroll 83–23 in the amount of \$13,695.89. Motion declared carried.

Moved by Hayes, seconded by J. Watkins, that the Regular Meeting of the City Council be adjourned. Motion declared carried.
