

MINUTES OF
GALENA CITY COUNCIL MEETING
TUESDAY, OCTOBER 20, 1986

CALL TO ORDER:

The Regular Meeting of the Galena City Council was called to order Tuesday, October 20, 1986, at 7:00 P.M. in the Council Chambers with Mayor John Stephenson presiding.

ROLL CALL:

Roll call indicated the following councilmembers present: Allen, Byrd, Brown, LaTurner, Watkins, Kay Kay, Hayes, Anderson. Absent: Jarvis, King.

MINUTES:

Moved by Kay Kay, seconded by Anderson, to approve and place on file the minutes of the Regular Meeting of the City Council of October 7, 1986. Motion declared carried.

Moved by Anderson, seconded by Hayes, to approve and place on file the Minutes of the Special Meeting of the City Council on October 16, 1986. Motion declared carried. 1-abstain--Kay Kay.

PLANNING & ZONING:

Moved by Anderson, seconded by Hayes, to approve and place on file the Minutes of the Planning & Zoning Commission of October 7, 1986. Motion declared carried.

TURKEY SHOOT:

Moved by LaTurner, seconded by Watkins, to allow the Blue Jay CB Club to conduct a turkey shoot behind the flea market near the IGA store, with benefits going to the Crippled Children. Motion declared carried.

UNDERAGE DRINKING ORD:

Garey Wilson was present to ask the City Council to approve the ordinance which would prevent underage persons from entering drinking establishments which he and others felt could help prevent exposure to drugs and other problems on the lot.

Moved by Allen, seconded by Hayes, to pass Ordinance 86-12 which would prohibit underage persons from entering drinking establishments. Roll call vote indicated: 4-yeyes: Allen, Watkins, Hayes, Anderson. 4-nays: Brown, Byrd, LaTurner, Kay Kay. 2-absent: Jarvis, King.

Ordinance declared failed.

CONDEMNATION-1708 MAIN:

Gene Porter spoke concerning the condemnation of 1708 Main. He stated he had been in contact with the owners and the attorney for the owner and felt the house was structurally sound and finances were available to repair the residence.

Moved by Kay Kay, seconded by Watkins, to give the owner until January 9, 1987 to complete repairs. Motion declared carried.

ROOF AT CITY HALL:

Moved by Kay Kay, seconded by Watkins to advertise for bids to make necessary repairs to the roof at City Hall. Advertisement will be for 2 weeks. Motion declared carried.

SWIMMING POOL REPAIRS:

Moved by Kay Kay, seconded by Anderson, to advertise for bids to correct problems at the Swimming Pool with Gene Porter to assist and make sure the repairs are properly done. Motion declared carried.

POLICE DEPARTMENT UNIFORMS:

Moved by Kay Kay, seconded by Watkins to allow the purchase of 3 winter shirts and 1 pair of pants for the Police Officers at \$28.95 each. Motion declared carried.

JACKETS FOR POLICE OFFICERS:

Chief Abram asked to replace coats for 4 or 5 officers which have been worn for 3-4 years. He was advised to get prices and bring back to the Council.

SCHOOL CROSSING GUARD:

Moved by Anderson, seconded by Kay Kay, to move Kim Martin up to full time School Crossing guard for Liberty School. Motion declared carried.

VACATION:

Moved by Watkins, seconded by Brown, to allow Gerald Hentz vacation from November 19-22 and a reserve officer be allowed to take his place. Motion declared carried.

RESERVE OFFICERS:

Moved by LaTurner, seconded by Kay Kay to refer to the Police Committee Garry Abram's request to add 6 more reserve officers to the present number of 12. Motion declared carried.

JACKETS FOR POLICE OFFICERS:

Moved by Watkins, seconded by Kay Kay, to allow the purchase of 4 coats for the Police Officers at \$70.00 each. Motion declared carried.

MEALS FOR ELECTION WORKERS:

Moved by Kay Kay, seconded by Watkins to allot \$2.50 per person for election workers on November 4, 1986. Motion declared carried.

POLICE PROCEDURE:

Moved by LaTurner, seconded by Brown to allow Kay Kay to air item on police procedure in the Council instead of going through Police Committee first. Motion declared carried.

Kay Kay referred to October 8, when a City Patrol Car dropped a person off at Riverton Quik Shop that was supposedly drunk. Abram explained that this person was held in City Jail for protective custody for County with a court order to be issued, then County decided not to issue a court order for a rehab problem, and Garry had his men to drop off this individual at Riverton intersection in an effort to help him get to Columbus for a rehab program.

TIRES FOR 920 LOADER:

Moved by Kay Kay, seconded by Brown to allow the purchase of 4 tires for the 920 loader for \$379.96 each from Goodyear. Motion declared carried.

TIRES FOR TRASH TRUCK:

Moved by Watkins, seconded by Kay Kay to allow the purchase of 2 tires for the Trash truck at \$151.90 each from Goodyear. Motion declared carried.

INSULATION FOR POLE BARN:

Moved by Kay Kay, seconded by Anderson, to advertise for bids on blown insulation for the Pole Barn. Motion declared carried.

SPROCKETS FOR STREET SWEEPER:

Moved by Byrd, seconded by Allen to purchase 4 sprockets for the street sweeper at \$119.40 each from the manufacturer. Motion declared carried.

TELEPHONE FRANCHISE-2ND READING:

Mayor Stephenson read the Telephone Franchise Ordinance for the second reading.

FIRE DEPT. CAR WASH EQUIP.:

Moved by Allen, seconded by Watkins, to allow the purchase of car wash equipment for the Fire Department at \$595.00 pending their approval of the machine and they will give the steam cleaner to the Street Dept. Motion declared carried.

Moved by Anderson, seconded by Byrd, to approve Appropriations Ordinance #86-23 in the amount of \$56,785.88. Motion declared carried.


ADJOURNMENT:
