MINUTES OF MEETING HELD OCTOBER 21, 1975.

COUNCIL MET IN REGULAR SESSION, MAYOR JACK MURRAY PRESIDING. COUNCILMEN PRESENT:

MOTION WAS MADE BY LA TURNER AND SECONDED BY AVICOLA THAT THE MINUTES OF MEETING HELD OCTOBER 7 BE APPROVED AND PLACED ON FILE. MOTION CARRIED.

MR. LOWELL RICHARDSON WAS PRESENT AT THE MEETING AND EXPLAINED THE WORK TO BE DONE ON NEXT YEARS H.U.D. APPLICATION WHICH MUST BE FILED BY THE LAST OF DECEMBER OR FIRST PART OF JANUARY. MR. RICHARDSON SUGGESTED THAT TWO PUBLIC HERRINGS BE HELD ON OFF-COUNCIL NIGHTS OF NOVEMBER 25 AND DECEMBER 9 FOR CITIZENS TO PARTICIPATE IN THE H.U.D. PROGRAM.

MOTION WAS MADE BY LA TURNER AND SECONDED BY BANKSON TO HOLD PUBLIC HEARINGS ON THE 2ND YEAR FUNDING OF THE H.U.D. GRANT ON NOVEMBER 25 AND DECEMBER 9 AT 7:00 P.M. MOTION GARRIED.

MOTION WAS MADE BY AVICOIA AND SECONDED BY LA TURNER TO ADOPT REHABILITATION FORMS WITH ASSETS OF \$7,500.00 EXCLUDING HOUSE AND AUTOMOBILE AND AN INCOME CEILING OF \$3,900.00 PLUS ALLOWANCES FOR ADDITIONAL FAMILY MEMBERS. PARTICIPANTS WOULD ALSO BE REQUIRED TO BE AN OWNER-OCCUPANT OF THE HOUSE. MOTION CARRIED.

MOTION WAS MADE BY AVICOLA AND SECONDED BY HANSBRAUGH TO AMEND ORDINANCE 898 SECTION 406 TO COMPLY WITH THE 1975 EDITION OF THE SOUTHERN BUILDING PLUMBING CODE ON MATERIAL USED IN SEWER HOOK UPS. MOTION CARRIED.

MOTION WAS MADE BY HANSBRAUGH AND SECONDED BY BOGLE TO REJECT THE CONTRACT ON SOLID WASTE COLLECTION PROPOSED BY THE BOARD OF COUNTY COMMISSIONERS. MOTION CARRIED.

AN APPLICATION FOR A BEER LICENSE FOR THE HAWK TO CLAUDIA MANOOGIAN WAS READ TO THE COUNCIL. MOTION WAS MADE BY BANKSON AND SECONDED BY BOGLE THAT THE LICENSE BE GRANTED UPON THE STIPULATION THAT THE PRESENT LICENSE BE SURRENDERED. MOTION CARRIED.

MOTION WAS MADE BY HANSBRAUGH AND SECONDED BY LA TURNER THAT C.D.B.G. ORDINANCE 75-2 BE APPROVED FOR PAYMENT. MOTION CARRIED.

MOTION WAS MADE BY BANKSON AND SECONDED BY LA TURNER THAT PAYROLL AND APPROPRIATION ORDINANCE 75-23 BE APPROVED FOR PAYMENT. MOTION CARRIED.

MOTION WAS MADE BY HANSBRAUGH AND SECONDED BY BANKSON TO TRANSFER \$16,625.00 FROM WATER UTILITIES TO THE BOND AND INTEREST ACCOUNT AND TRANSFER \$7,829.36 FROM REVENUE TO WATER UTILITIES. MOTION CARRIED.

MOTION WAS MADE BY HANSBRAUGH AND SECONDED BY AVICOLA THAT THE BOND AND INTEREST PAYMENT OF \$39,562.48 BE PAID. MOTION CARRIED.

MOTION WAS MADE BY HANSBRAUGH AND SECONDED BY BARKER FOR THE PURCHASE OF 55 GALLONS MOTOR OIL AT A COST OF \$102.95 AND A LOAD OF ROAD OIL AT A COST OF \$1,887.29. MOTION CARRIED.

MAYOR MURRAY APPOINTED A COMMITTEE OF BANKSON, BOGLE, AND LA TURNER TO WORK ON THE REAPPORTIONMENT OF THE CITY WARDS.

MOTION WAS MADE BY AVICOLA AND SECONDED BY LA TURNER THAT THE MEETING ADJOURN. MOTION CARRIED.
