Moved by Little, seconded by Colgrove, to approve and place on file the minutes of the Special Meeting on October 28, 1983. Motion declared carried.

MUSEUM:

Jerry Derfelt appeared before the council to request permission for the city crew to help level the lot to be used for the museum building. He also wanted to know whether the school board or the city would be responsible for maintaining the the drive and culvert to be put in off of the state highway. It was decided that the school board should write the letter and assume the responsibility.

FIRE DEPARTMENT TIRES:

Moved by Allen seconded by Hayes to purchase 4 tires at the cost of \$412.00 from Burgraff Tire, for the main tank truck. Motion declared carried.

MUSKRAT TRAPPING AT LAGOONS:

Moved by Little, seconded by R. Watkins, to allow Bob Hausenplaugh to trap muskrats again this year at the lagoons. Motion declared carried.

VACATIONS:

Moved by R. Watkins, seconded by Little, to approve one week vacation for Rodger Swaney starting Nov. 8. Motion declared carried.

Moved by Little, seconded by Hayes, to approve 1 week vacation from Nov. 14-18 and 1 week pay in lieu of vacation for Rex. Gandy. at Motion-declared carried.

POLICE ACADEMY:

Moved by Little, seconded by R. Watkins, to allow Dale Vickers to go to the police academy January 2, 1984 with expenses of \$300. Motion declared carried (2 nays - Means, Hayes)
