MINUTES OF REGULAR COUNCIL MEETING NOVEMBER 1, 1988

CALL TO ORDER:

The Regular Meeting of the City Council of the City of Galena was called to order Tuesday, November 1, 1988 at 7:00 P.M. in the Council Chambers with Thomas Y. Allen, Mayor, presiding.

ROLL CALL:

Roll Call indicated the following Council Members present: Hayes, Little, King, Byrd, Stephenson, Fitzer, Tipton, Jenkins Absent: Poelma, Qualls

MINUTES:

Moved by Jenkins, seconded by Tipton to approve and place on file the minutes of the Regular Meeting of October 18, 1988. Motion declared carried.

HENTZ VACATION:

Chief Collins requested that Patrolman Gerald Hentz be granted one week's pay in lieu of vacation even though he had already used this vacation option earlier this year. Chief Collins stated that with the current number of police officers, he would have to have a reserve fill in for Officer Hentz to take his vacation time. He noted that the city would not save any money by having to pay this reserve instead of Officer Hentz.

Moved by Byrd, seconded by Hayes to grant Gerald Hentz one week's pay in lieu of vacation. Motion declared carried. Nay: King

POLICE DEPARTMENT:

Chief Collins reported to the Council that he had forwarded the three grant applications approved at the October 18 meeting to Topeka.

He also had sent a letter concerning the traffic lights for the school zone on East 7th Street.

WHISTLE 12TH & DEWEY:

Superintendent Sills requested he be allowed to purchase a 32 foot galvanized whistle for 12th & Dewey Streets at a cost of \$280.17.

Moved by Little, seconded by Hayes to allow this purchase. Motion declared carried.

ROAD GRADER REPAIR:

Superintendent Sills reported he had repaired the road grader at a cost of approximately \$417.

920 LOADER:

Superintendent Sills reported the 920 loader had water in the oil. He stated EA Martin Machinery Co. told him this machine could not be overhauled again.

Moved by King, seconded by Fitzer to refer the repair of the 920 loader to the street committee for next council meeting. Motion declared carried.

It was necessary for the City of Galena to pass a resolution approving these bonds before the County Commissioners can issue the bonds.

Moved by King, seconded by Jenkins to accept and place on file the court report for October with fines totaling \$1048.00. Motion declared carried.

CONGREGATE MEALS BULLETIN BOARD:

Moved by Little, seconded by King to allow SEKAP to install a bulletin board in the Community Room with city employees doing the installation. Motion declared carried.

qualifications were reviewed by each council
person and individual tally sheets were completed by each. Scores for each firm were
tallied and Engineering Design, Wilson and
Company and A.C. Kirkwood received the 3
top ratings.

Moved by King, seconded by Tipton to invite Engineering Design, Wilson and Company and A.C. Kirkwood engineering companies to meet with the Council at a special meeting on November 10, 1988 at 7:00 P.M. Motion declared carried.
