COUNCIL MET IN REGULAR SESSION, MAYOR JACK MURRAY PRESIDING.

MOTION WAS MADE BY AVICOLA AND SECONDED BY BANKSON THAT THE MINUTES OF MEETING HELD OCTOBER 21, 1975 BE APPROVED AS AMENDED. MOTION CARRIED.

MOTION WAS MADE BY BANKSON AND SECONDED BY HANSBRAUGH THAT THE POLICE REPORT FOR OCTOBER IN THE AMOUNT OF \$965.00 BE ACCEPTED AND PLACED ON FILE. MOTION CARRIED.

MOTION WAS MADE BY HANSBRAUGH AND SECONDED BY BANKSON TO HAVE PLANNING AND ZONING COMMITTEE CHECK ON DUPLEX BUILDING FOR BOB CARR. MOTION CARRIED.

MOTION WAS MADE BY HANSBRAUGH AND SECONDED BY AVICOLA UPON A LETTER OF RELEASE FROM R.L. CARTER, THAT JACK HUMBLE BE GRANTED ONE ACRE OF INDUSTRIAL TRACT SOUTH OF PRESENT INDUSTRY. MOTION CARRIED.
