She asked that future bids for street repairs include both the city doing the preparation of the streets and the contractor preparing the streets. She also asked that the council receive a cost estimate, including the man hours, of city expense when the city does the preparation.

No action was taken on this bid at this time. The city will pave the ball park first and then the streets will be done when funds are available.

MORAN RESIGNATION:

Norman Moran, Councilmember from 4th Ward, resigned due to ill health.

City Inspector read his statement concerning the condition of the structure at 1008 E. 9th which had been destroyed by fire. At the time the statement was prepared, the structure was still standing. However, the owners have taken the structure down but the lot remains to be cleaned. He stated there are funds in the Fire Insurance Escrow Account and the condemnation is necessary should the city have to clean the lot.

WALKING TRACK:

Gourley stated she and Ben Biddle met with the Chamber of Commerce concerning the walking track. She stated the chamber would be willing to contribute up to \$750 on cleaning the creek bed beside the track.

Jim Oglesby, President of the Chamber, stated they had invested approximately \$17,000 in this track including solicitations obtained. They requested the city take over the project and the upkeep. He stated the Chamber would be happy to assist when the city has "clean up day" at the track.

The council discussed various ways to clean the creek bed. The city attorney stated Noxious Weeds funds could not be used for this.

Park Caretaker stated he had provided the city with an offer of \$1400 from Burrows Construction at the October 15 meeting.

The park committee thanked Mr. Oglesby and Mr. Snapp for their assistance.

Moved by STANSBERRY, seconded by BYRD to table the cleaning of the creek bed at the walking track until funds are available.

SWIMMING POOL REPAIR:

The council discussed replacing the underwater lights at the pool while the repairs on the skimmer are being done. Park Caretaker stated it would cost approximately \$1800 to replace 9 lights.

DOANES WASTE:

The sanitation committee met with Hillbilly Sewer concerning Doanes waste being placed in one of the city manholes part time. The waste

will be from showers and rest rooms and will only be placed there when Hillbilly has another stop before returning to his home base. This is currently being done for Tri State Recycling, and Hillbilly pays the current sewer rate for any waste placed in city lines.

TRT MEETING:

The sanitation committee met with Mr. Bayliss of TriState Recycling concerning a contract for them to use the city's demolition landfill. Another meeting is scheduled for Wednesday at 4:00 p.m.

DEMOLITION LANDFILL:

A copy of a letter from Bill Towery of KDHE concerning the landfill was included in the packets. Burkybile stated the holes were filled and the landfill leveled on Tuesday and a letter will be sent to Mr. Towery informing him of this.

NORTH COLUMBUS STREET:

The street committee stated they had not met concerning North Columbus Street.

Chief Collins suggested we contact the County Engineer to make a recommendation. He stated the council might consider putting shoulders and large signs at the location of the accidents.

Moved by BYRD, seconded by WILLIAMS to request the County Engineer to make a recommendation on North Columbus Street.
