## WATER COMMITTEE REPORT:

Commissioner Oglesby gave an overview of the water committee meeting. He stated an alternative water supply in the future is imperative. Spring River Water District, which the commission voted to join, is probably five years in the future. American Water Company is putting a 12 in. water line to the empire District plant on state line and has offered to extend it into the city for an additional water source. He noted the city is now approximately 500 gallons per minute and 200 additional gallons per minute should be adequate. Mr. Oglesby advised we would not be selling any of our water rights, we would only be purchasing water.

City Manager, Jack Murray said as he understood American Water was not going to force us to buy 200 gallons, they have agreed to soften that, and at their own risk have agreed to up size the pipe from 6in. to 12 in.

Commissioner Oglesby stated the water committee had voted and it was anonymous that going with American Water was the most obvious thing to do and it was not encumbering the city. Commissioner Oglesby stated at this time American Water was expecting a 200 gallon per minute commitment.

Motion made by Jackson, seconded by Brandenburg to proceed forward on the recommendation of the water committee. **Motion declared carried**.

## KANSAS MUNICIPAL INSURANCE TRUST:
