STANDARD TRAFFIC CODE:

Motion made by Jackson, seconded by Oglesby to approve Ordinance 99-10 the Standard Traffic Ordinance for Kansas Cities. Motion declared carried

K-9 UNIT:

Commissioner Oglesby suggested a committee be appointed to study the issue and bring recommendations back to the commission.
