MINUTES OF THE GALENA CITY COUNCIL, GALENA, KANSAS, NOVEMBER 19, 1968

The council of the city of Galena, Kansas, met in regular session in the council chamber at the city hall building at 7 o'clock, p.m., November 19, 1968.

Present: Councilmen Pittman, Brown, Martin, Kitch, Watkins, Bogle, Kaehler, and Tackett.

Absent: Councilmen Cure and Barker.

Presiding: Frank P. Dillon, Mayor.

Also present: City Attorney Yount, City Marshal Karr, Supt. of Works Barnes, and Clerk Chesnutt.

Councilman Pittman moved, seconded by Councilman Brown, that the reading of the minutes for the preceding meeting be dispensed with and same placed on file as presented. Motion carried by a show of hands.

Mayor Dillon read a complaint from Mrs. Angel requesting repairs be made to the State Line Road, same being within the city limits. Councilman Pittman moved, seconded by Councilman Watkins, that the complaint be referred to the Service Committee for determination. Motion carried by a show of hands.

Councilman Watkins requested that the hours of the men setting up voting booths for the general election held November 5, 1968, be furnished to the clerk's office in order that a voucher might be submitted to the county clerk's office for payment of same.

Councilman Pittman moved, seconded by Councilman Watkins, that Mr. Barnes paint a restricted zone sign in front of the doctors' office, located at 118 East Fifth Street, in order that ambulance service might be rendered. Motion carried by a show of hands.

Councilman Pittman moved, seconded by Councilman Watkins, that two (2) tires be purchased at a cost of \$22.47 each for use on the patrol car. Motion carried on roll call vote as follows: Yeas - Councilmen Pittman, Brown, Martin, Kitch, Watkins, Bogle, Karr, and Tackett. Nays - none. Mayor Dillon declared passage of the motion.

Councilman Pittman introduced Ruth Lang to the Governing Body. Miss Lang requested a rebate on her occupation license. The city attorney advised the Governing Body and Miss Lang that the city had no provision for making rebates and explained briefly the intent and purpose of the ordinance covering occupation taxes.

Councilman Watkins introduced an appropriation ordinance numbered 562 for making payment of certain claims; the meeting being public the ordinance was discussed. On its third and final reading the ordinance was passed on roll call vote as follows: Yeas - Councilmen Pittman, Brown, Martin, Kitch, Watkins, Bogle, Kaehler, and Tackett. Nays - none.

Councilman Kaehler moved, seconded by Councilman Pittman, that the Empire District Electric Company be requested to install a street light at the corner of Twelfth Street and State Line Road. On roll call the vote was as follows: Yeas - Councilmen Pittman, Brown, Martin, Kitch, Watkins, Bogle, Kaehler, and Tackett. Nays - none.

Councilman Pittman moved, seconded by Councilman Brown, that the meeting be adjourned. Motion carried on a standing vote.
