

MINUTES OF REGULAR COUNCIL MEETING HELD NOVEMBER 21, 1978.

COUNCIL MET IN REGULAR SESSION, MAYOR MURRAY PRESIDING.

COUNCIL MEMBERS PRESENT:

MOTION WAS MADE BY WADE AND SECONDED BY REED THAT THE MINUTES OF REGULAR COUNCIL MEETING HELD NOVEMBER 7, 1978, AND SPECIAL COUNCIL MEETING HELD NOVEMBER 7, 1978, AND SPECIAL COUNCIL MEETING HELD NOVEMBER 16, 1978, BE AMENDED AND PLACED ON FILE. MOTION CARRIED.

MOTION WAS MADE BY BANKSON AND SECONDED BY HAYES TO GIVE CARL LEWIS TWO WEEKS PAY IN LIEU OF VACATION. MOTION CARRIED.

MOTION WAS MADE BY BANKSON AND SECONDED BY WADE TO ISSUE A 1978 OCCUPATION LICENSE TO THE MOON RAKER RESTAURANT. MOTION CARRIED.

MOTION WAS MADE BY WADE AND SECONDED BY REED THAT SALESMEN SUCH AS AVON LADIES, FULLER BRUSH, AND TUPPERWARE DEALERS AND ETC. MUST PURCHASE AN OCCUPATION LICENSE. MOTION CARRIED. (1)ABSTAINED MEANS

MOTION WAS MADE BY DAVIES AND SECONDED BY MEANS TO ALLOW THE GALENA BASKETBALL ASSOCIATION THE USE OF THE COMMUNITY ROOM FOR DECEMBER 3 AT 2:00 P.M. MOTION CARRIED.

MOTION WAS MADE BY BANKSON AND SECONDED BY WADE THAT FOUR TIRES BE PURCHASED FOR POLICE CAR #204 FROM GOODYEAR TIRE SERVICE TO BE PAID OUT OF THE REVENUE SHARING FUND. MOTION CARRIED.

MOTION WAS MADE BY REED THAT THE CITY ATTORNEY DRAWN UP AN ORDINANCE TO LIMIT RUMMAGE SALES TO TWO A YEAR AND FOR THEM NOT TO RUN OVER 3 DAYS EACH. MOTION FAILED FOR LACK OF A SECOND.

MOTION WAS MADE BY WADE AND SECONDED BY ALLEN THAT ORDINANCE #999 THAT INCLUDES ADDING VETERANS DAY AS A LEGAL PAID HOLIDAY BE APPROVED AND PLACED ON FILE. MOTION CARRIED.

MAYOR MURRAY PRESENTED THE COUNCIL WITH THE NAMES OF TERRI ANDERSON AND SCOTT SHAW FOR CONFIRMATION AS AUXILIARY POLICE.

MOTION WAS MADE BY BANKSON AND SECONDED BY WADE THAT TERRI ANDERSON AND SCOTT SHAW BE CONFIRMED AS AUXILIARY POLICE. MOTION CARRIED.

MOTION WAS MADE BY MEANS AND SECONDED BY WADE THAT THE BEER LICENSE OF LETITIA LINK BE TABLED UNTIL THE ZONING PROBLEM HAS BEEN SETTLED. (3)NAYS BANKSON, DAVIES, REED. (4)YEAS HAYES, ALLEN, MEANS, WADE. MOTION CARRIED.

MOTION WAS MADE BY DAVIES AND SECONDED BY WADE THAT THE CITY ATTORNEY DRAFT AN ORDINANCE CREATING THE HIRING OF AN ATTORNEY TO REPRESENT INDIGENT DEFENDENTS IN THE MUNICIPAL COURT AT \$35.00 PER CASE. MOTION CARRIED.

MOTION WAS MADE BY WADE AND SECONDED BY DAVIES TO SECURE THE PUBLIC OFFICIAL LIABILITY TO BE PAID OUT OF THE GENERAL FUND AT A COST OF \$4,020.00. MOTION CARRIED.

MOTION WAS MADE BY WADE AND SECONDED BY DAVIES THAT THE \$4,020.00 FOR PUBLIC OFFICIAL LIABILITY BE ADDED TO APPROPRIATIONS 78-27. MOTION CARRIED. (1)ABSTAINED ALLEN

MOTION WAS MADE BY MEANS AND SECONDED BY WADE THAT WE SET ASIDE A SPOT FOR A MUSEUM EAST OF ZODIAC 300 FT. DEEP AND WITH A 150 FT. FRONTAGE. MOTION CARRIED.

MOTION WAS MADE BY BANKSON AND SECONDED BY WADE THAT WALTER F. STEPHENS, JR. BE PAID \$305.48 TO BE PAID OUT OF REVENUE SHARING FUND AND ADDED TO APPROPRIATIONS ORDINANCE 78-26. MOTION CARRIED.

MOTION WAS MADE BY BANKSON AND SECONDED BY WADE THAT PETERS WRECKER SERVICE BE PAID \$75.75, AMERICAN LEGION BE PAID \$90.00, KANSAS STATE TELEPHONE CO. BE PAID \$332.01, LEAGUE OF KANSAS MUNICIPALITIES BE PAID \$11.00, HOWARD JARVIS BE PAID \$24.00, AND SHAMBLIN USED CARS BE PAID \$1,100.00 AND ALL THESE ADDED TO APPROPRIATIONS 78-27. MOTION WAS MADE BY WADE AND SECONDED BY BANKSON THAT PAYROLL ORDINANCE 78-25 AND 78-26 IN THE AMOUNT OF \$8,752.04 AND APPROPRIATIONS 78-25 IN THE AMOUNT OF \$37,414.98 BE APPROVED FOR PAYMENT. MOTION CARRIED.
