He said they have to go into executive session so much maybe they could alleviate some of this by one commissioner being able to talk to another and bouncing an idea off of him if there is a problem. He said the only bad thing about changing the quorum the majority of the commissioners would have to be there.

Commissioner Donaldson stated at the time he may not have presented it properly and the time may have not been right, but he had done his homework on it and the League as well as an attorney had suggested changing it. Not so they could hide behind closed doors or talk among each other and figure things out.

Motion made by Donaldson, seconded by Shoemaker that pending the city attorneys investigation if it proves to be okay with the League that they raise the quorum to four through charter ordinance thereby making the majority three. **Motion declared carried**.
