MOTION WAS MADE BY DAVIES AND SECONDED BY HOPKINS THAT THE MINUTES OF REGULAR COUNCIL MEETING HELD NOVEMBER 21, 1978, AND SPECIAL COUNCIL MEETING HELD NOVEMBER 28, 1978, BE AMENDED AND PLACED ON FILE. MOTION CARRIED.

MOTION WAS MADE BY BANKSON AND SECONDED BY REED THAT VACATIONS BE APPROVED FOR THE FOLLOWING PEOPLE: RICHARD MONTEE_DECEMBER 27 TO JANUARY 5, STEVE PITTMAN_ONE WEEK PAY IN LIEU OF VACATION, CHIEF MYERS_ONE WEEK PAY IN LIEU OF VACATION, MARY ANN LITTLE_STARTING DECEMBER 27—JANUARY 5, RAYMOND FORAKER_ONE WEEK PAY IN LIEU OF VACATION, BOB BROWN_ONE WEEK PAY IN LIEU OF VACATION, AND GEORGE HERRELSON_TWO WEEKS PAY IN LIEU OF VACATION.
