MINUTES OF GALENA CITY COUNCIL MEETING DECEMBER 6, 1983

CALL TO ORDER:

The Regular Meeting of the City Council of the City of Galena was called to order by Mayor James Bankson at 7:00 P.M., in the Council Chambers, on Tuesday, December 6, 1983.

ROLL CALL:

Roll Call indicated the following councilmembers present Gibson, King, Hayes, Means, Little, Anderson, Colgrove, R. Watkins, Allen. Absent: J. Watkins.

MINUTES:

Moved by Anderson, seconded by Hayes, to approve and place on file the minutes of the Regular Meeting on November 11, 1983. Motion declared carried. (King abstained)

DAV:

Moved by Colgrove, seconded by R. Watkins, to approve and place on file the minutes of the Special Meeting on November 29, 1983. Motion declared carried.

BLUE CROSS:

Clarence Hall, a member of the DAV, appeared before the council requesting information on any condemned property that they might be able to buy from the owner. The city clerk was instructed to give Mr. Hall any property owners name after a hearing was set and the notice published.

Judy Spaulding with Blue Cross and Blue Shield of Kansas presented the council with their bid for 1984. Plan A with \$100 deductible for family would be \$181.95 and \$67.01 both including life. Plan B with \$200 deductible would be \$174.64 and \$64.47.

The other insurance bid are to be in the city clerks office December 16 and will be given to the Insurance Committee.

FIRE CONTRACTS:

Councilmember Little informed the council that the City had received a contract in the form of an ordinance from both Neosho and Joplin and would be receiving them from several other cities concerning the creation of a pool of fire fighting equipment and personnel from the respective fire departments of the contracting cities and to set up with said cities a plan of Mutual Assistance in case a major conflagration or a major disaster should occur in any of said cities.

The City of Galena will either type up a Resolution or an Ordinance whichever will be sufficient in order for us to enter into the contract.

SHOWER & CARPET FOR PARK HOUSE:

Moved by Allen, seconded by Colgrove, to purchase a shower from Pearl Brothers for \$139.00 and to replace the floor in the bathroom. Motion declared carried.

Moved by Allen, seconded by Colgrove, to look into more prices for indoor —outdoor carpet and bring them back to the next council meeting. Motion declared carried.

SALARY INCREASE ORDINANCE NO.83-22:

Moved by Little, seconded by R. Watkins, to approve a salary increase ordinance #83-22 that would give all full-time salary employees a \$25.00 a month raise and part-time salary and hirely employees a 5% raise to become effective January 1, 1984. Roll call vote indicated:

The salaried pay periods will be the 15th and the 30th starting the 30th of December.
