

MINUTES OF  
GALENA CITY COUNCIL MEETING  
DECEMBER 7, 1982

CALL TO ORDER:

The regular meeting of the City Council of the City of Galena was called to order by Mayor Thomas L. Wade, at 7:00 P.M., in the Council Chambers on Tuesday, December 7, 1982.

ROLL CALL:

Roll Call indicated the following councilmembers present: Adams, Hayes, Little, J. Watkins, Bankson R. Watkins, Allen. Absent: Shallenburger, Means, Murray.

MINUTES:

Moved by J. Watkins, seconded by R. Watkins, to approve and place on file the minutes of the Regular Meeting on November 16, 1982. Motion declared carried.

Moved by Little, seconded by Bankson, to approve and place on file the minutes of the Special Meeting on November 30, 1982. Motion declared carried.

INSURANCE BIDS:

Representatives from 3 insurance companies were present to discuss their health and life insurance rates for a group policy for City employees. Four bids were submitted: Bankers Life, Travelers, Blue Cross, and Aetna.

Moved by Bankson, seconded by Little, to allow Judy Johnston to work 3 extra days in the City Clerk's Office in December to help close out the year. Motion declared carried.

Moved by Bankson, seconded by J. Watkins, to give \$10.00 Gift Certificates to City employees to be used toward the purchase of a turkey or ham. Motion declared carried.

PARK HOUSE:

Moved by Adams, seconded by R. Watkins, to allow Donnie Youngblood to live in the house at the Schermerhorn Park with utilities paid in exchange for his being security guard until the May appointments. Motion declared carried.

CONDEMNATIONS:

City Clerk is to send a certified letter to John Neale and FDIC giving him 10 days to respond to the City concerning his condemned house or the City will tear it down immediately after the 10 days have expired.

City Clerk is to send a notice to Jack Lee, Myrtle Lawing and Fred Titus requesting them to come to the next meeting concerning their condemned houses.

DOORS:


Moved by Allen, seconded by Little, to allow the Fire Department to replace 2 doors from their funds. Motion declared carried.


ADJOURNMENT:
