The city's Subdivision rules they are trying to go by was filled with inconsistency and contradiction within the policy itself, noting it needed to go but needed a replacement with more thought put into it.

She stated Thompson had done everything he was asked to do to comply. Concerns of the property committee are they know they want him to put in roads. She felt he had did every thing he could but they had dragged their feet for six weeks unintentionally, but in doing so gone were the warm days for laying asphalt. She asked Council member Cure if he wanted to talk on what the property committee had come up with for a possible proposal. Proposed was to ask that the Planning and Zoning waive the construction dead line so Thompson could have some lead way.
