City Manager, Jim Ray said when a Chief of Police dies while in office, by natural cause or in line of duty; it is customary to retire the badge worn by that Chief. It can be passed on to a senior member of the family or can be placed in a prominent place in the department. The officers that had worked with Chief Horn had expressed the wish to pass the badge on to his father.
