WATER TRUCK:

Council member Shoemaker said Loundry Car Co. in Grove, Oklahoma has a 98 Chev. 2500 Series with utility bed advertised for \$13,652.00. He had contacted them and they agreed to take \$13,100.00. The Equipment Reserve Fund has \$4,089.02 in it.

Council member Cure said he would make a motion to purchase the truck but would like to see it come out of the Water Fund.

City Superintendent, Mittag said Fitzer is suppose to push the tires in once a week that's his part of the deal.

#### **BOOT BLOCK:**

Mayor Frazier said she had two requests for Boot Blocks, but was not willing to give permission until she spoke to the council.

Council member Shoemaker said they had discussed this at a previous meeting when Paul Nolan wanted to have one for Bulldogs against Drugs (BAD) and decided to give their blessings not their permission. City Attorney, Cure said he would look and see if there are any infractions on having the boot blocks.

# SIGN NATURE CENTER & SCHERMERHORN PARK:

Council member Cure said he would like to see a new sign for Schermerhorn Park and the Nature Center. The current sign is terrible. The Nature Center has invested thousands of dollars in the center. Maybe the Brick committee or city could get involved in the project.

## VACATING PART OF SHAW HILL RD.:

Mayor Frazier said she would take the City Surveyor's recommendation of not vacating part of Shaw Hill.

Mr. White's recommendation was to consider posting a 5 ton load limit with a stiff enough fine to pay the cost of watching the road.

Council member Cure said he would like to see the sign and have the Chief's officer's watch. Asked by City Superintendent, Mittag if they wanted it limited to 5 Ton.
