week prior to their visit.

Randy Youngblood, Assistant City Superintendent, and David Strickland, city employee, opened a fire plug and cleared a line a week prior to the

complaint.

WATER TOWER:

Water committee had a meeting in regards to the tower and they was waiting for the information back from the state on what exactly the state wanted the city to do.

**FEMA TRAILERS:** 

Kevin Cure, City Attorney, stated Peco Drive was not zoned for mobile homes. City can not do anything until there is a planning and zoning commission composed to go forward and it is hard to find members to sit on it. There are seven positions on this commission and there are three positions filled at this time, to rezone we need a planning and zoning commission.

FRANK CHEW:

Frank Chew, Miracle Valley Church, stated the water pressure for his church and for the residents on old 7<sup>th</sup> Street was horrible. Jerry Richey, City Superintendent, brought some recommendations to this meeting, Run a 4 inch up from the Nursing Home, behind the Assembly of God Church, bore under the railroad, measured at 3500 feet. Jerry stated he was trying to get an easement from Mars, so that they can go from OASIS at the 6 inch main and run it down the ditch line it would cut off at least 1000 feet, tie it back into the 2 inch and then put the 4 inch back into the copper. That way it would loop. He received an estimate from Warstler, \$44500.00 to come from the Hospital, \$43900.00 from OAISIS. He also has contacted the gentleman from Riverton and Mr. Webber for estimates. Other suggestions were having pressurized water truck, having O'Brien's pump at night to fill their reservoirs or trucks, rationing or a special assessment of property. It was asked that Kevin Cure, City Attorney, to get with O'Brien's on the problem and its solutions.

**SCHERMERHORN PARK:** 

State Representative, David Jenkins, stated the city needs to submit a request to pull the gravel off of gravel bar where it washed out after the last flood, but he wants it to stay at the top of the water level where it is now just to pull from where it is now and not to go down any further. Mr. Jenkins will send pictures and a form of letter to help us to send in the request. If we remove any rock or trees from Shoal Creek it has to be permitted by the state or we can lose our swimming rights. Sand is needed at the park.

SCHERMERHORN PARK BATHROOMS:
