


MINUTES OF  
GALENA CITY COUNCIL MEETING  
MARCH 31, 1981

- CALL TO ORDER: The special meeting of the City Council of the City of Galena was called to order by Mayor Dolores Smith, at 7:00 P.M. in the Council Chambers on Tuesday, March 31, 1981.
- ROLL CALL: Roll Call indicated the following councilmen present: Hayes Means, Watkins, T. Wade, A. Wade, Moody.  
Absent: Mann, Rosenberry, Piercefield, Kelley.
- APPROVE PAYROLL 81-7 Moved by Watkins, seconded by T. Wade to approve Payroll 81-7. Means abstained. Mayor voted yes in order to carry the motion. Motion declared carried.
- C.D. OFFICE PARK GRANT Moved by T. Wade, seconded by Watkins to have a letter of intent written. The City will spend \$5000 on ball park and receive matching funds from the Land and Water Conservation Fund if and when funds are available. Motion declared carried.
- C.D. OFFICE Moved by Moody, seconded by Hayes to allow the Community Development office to be used by the Building Inspector and the Planning & Zoning Commission after the regular C.D. Office closes. Motion failed.
- C.D. PAYROLL & APPROPRIATIONS Moved by T. Wade, seconded by Moody to approve C.D. Payroll and Appropriations after amending them to include Sutherland for \$2,530.16 and Joplin Supply for \$751.73 for a grand total of \$10,723.35.
