FIRE DEPARTMENT:

MAPS OF CITY:

City Manager, Jamie Bell told the commission that the engineering firm they hired for the landfill said they could do some maps for the city. Cost at first was \$300.00 and ended up at \$2,400.00, which was not feasible for the city at this time.

ECONOMIC DEVELOPMENT:

City Manager, Jamie Bell informed the commission that Subway was still looking at coming into the city and was looking at some potential sites.

In other economic development the commission discussed legislation in Kansas for a casino, putting in a tire monofill, cutter and shredder for a tire monofill.

Mayor Hardman said it was her understanding that the bathroom at the cemetery house is in bad shape and so is the roof on the house. The commission asked for recommendations to be brought back before the commission with numbers on cost of repair.

City Manager, Jamie Bell gave an update on the landfill. It is his understanding through the engineering firm that they will assist in filling for and extension and his understanding per the engineering firm, that the state is giving us a 6-month leniency on this. City Superintendent Sonny Webster said what this means is they will probably give us six months before they start enforcing anything.

TRIAD HOUSING LONNIE PENDER:

Commissioner Shoemaker asked if there had been any contact with the development of housing on 17th Street. City Manager, Jamie Bell said he had talked with Bill Shoemaker on it before he got sick, but would do some follow up.

Commissioner Davies stated he would like to see a report back on it.

MAIN STREET PROGRAM:

City Manager, Jamie Bell informed the commission that the Kansas Main Street Program would speak before the commission at the April 5th meeting.

TRUCK ROUTE:

Commissioner Shoemaker said the trucks going down Main Street was a sore spot of a lot of people. He felt something could be changed to keep the trucks off of Main Street. He stated he would like the city manager to speak with Larry Courtney about putting a concrete apron at C & N for the trucks.
