CALL TO ORDER:

Burkybile recommended a different firm audit the books each 3 years. This would be fair and rotate the money the city spends with more than one firm.

It was asked if Mrs. Hill could do the audit. She would meet with the council to discuss it.

The Council discussed whether the books should be removed and whether Mr Mense should do the audit since he had been contracted with.

Allen also asked what years were to be audited and why it was necessary to audit the years that had been audited by Mr. Mense.

Allen recommended that the books be kept in the police department until they are audited to protect the City Clerk.

Moved by BURKYBILE, seconded by SCOTT that the Council meet with DeAnn Hill and check things out, keep 90 through 93 books in the police department and name Alan Wade as custodian and allow the City Treasurer to obtain figures for the quarterly reports.
