

## MINUTES OF SPECIAL MEETING OF THE GALENA CITY COUNCIL, APRIL 25, 1967

Upon request of Councilmen Darrell W. Kitch, Cletis M. Barker, William (Bill) Karr for the purpose to make appropriation for payment of Federal Withholding Taxes, FICA, Kansas State Taxes, State Sales Tax, and releasing of draft-warrants drawn on the 15th of March as approved by Appropriation Ordinance No. 520, and discussion of water problems, Mayor Frank P. Dillon called a special meeting of the Galena City Council, April 25, 1967, at 7 o'clock, p.m., in the council-room at the city hall.

Present: Councilmen Piercefield, Watkins, Cure, Kitch, Karr, and Pittman.

Presiding: Mayor Frank P. Dillon.

Absent: Councilmen Hammontree, Barker, and Duley.

Also present: City Marshall Hamlin and Betty B. Chesnutt, City Clerk.

Mayor Dillon opened the meeting with a short prayer, followed by the reading of the object and purpose of the meeting.

Councilman Watkins moved, seconded by Pittman, that by roll call vote the following resolution be passed and adopted by the Council.

WHEREAS, draft-warrant G 4651, dated March 15, 1967, and approved for payment on Appropriation Ordinance No. 520, in the sum of \$544.12, is signed by Mayor Arthur Milton Moeller, and City Treasurer Clifford McQuillen only;

BE IT RESOLVED, that the foregoing listed drafts, G 4565 to and inclusive G 4545, be signed by Mayor Frank P. Dillon and his signature attested by Betty B. Chesnutt, City Clerk; and the signature of Mayor Arthur Milton Moeller be attested by Betty B. Chesnutt, City Clerk, on draft-warrant No. G 4651; and said draft-warrants be released to the claimants heretofore listed.

Motion carried on roll call vote as follows: Yeas - Piercefield, Watkins, Cure, Kitch, Karr, and Pittman. Nays - None.

Councilman Watkins moved, seconded by Councilman Pittman, that the city clerk be authorized to draw draft-warrants payable to the District Director of Internal Revenue in the sum of \$843.36 for quarterly federal taxes; State Contribution Fund, FICA taxes, in the sum of \$1,753.94; Director of the State Revenue Department, for Kansas State Income Taxes withheld from employees in the sum of \$217.89; and Director of Revenue for the State of Kansas for payment of State Sales Tax in the amount of \$24.93. Motion carried on unanimous roll call vote as follows: Yeas - Piercefield, Watkins, Cure, Kitch, Karr, and Pittman.

Councilman Pittman moved, seconded by Piercefield, that Superintendent James F. Roberts be requested to furnish all employees of the Water Department, if necessary, to finish reading the water meters immediately. Motion carried viva voce.

Councilman Barker entered and took his seat at 8 p.m.

Councilman Pittman moved, seconded by Piercefield, that the meeting be adjourned. Motion carried viva voce.
