THE MAYOR BROUGHT BEFORE COUNCIL, WILLIAM KARR FOR CIVIL DEFENSE DIRECTOR OF GALENA. MOTION WAS MADE BY COUNCILMAN BOGLE AND SECONDED BY COUNCILMAN HANSBRAUGH THAT APPOINTMENT BE CONFIRMED. MOTION WAS CARRIED BY UNANIMOUS VOTE.

COMMITTEE CHAIRMAN ARE TO MEET WITH MR. KARR AFTER HE CONTACTS PROFESSIONALS TO DETERMINE HIRING OF PERSONS FOR CLEAN UP. MOTION WAS CARRIED UNANIMOUS.
