COUNCIL MET IN SPECIAL SESSION WITH MAYOR MANOR MURRAY PRESIDING:

PURPOSE OF THE MEETING BEING TO PAY FOR CLEAN UP AND FUND TRANSFERR.

COUNCILMAN HANSBAUGH EXPLAINED THAT HE HAD ENGAGED THE FIRM OF R.E. LAYMON, OPERATING UNDER THE NAME OF THE B & L TREE SERVICE. CLEAN UP FOR THE CEMETERIES BEING AT A BID OF \$1550 LATER WHICH WAS REDUCED TO THE BID OF \$1350. MOTION WAS MADE BY COUNCILMAN HANSBAUGH AND SECONDED BY COUNCILMAN BROWN THAT THE B & L TREE SERVICE BE PAID THE SAID SUM OF \$1350. ONE THIRD THE AMOUNT FROM THE CEMETERY ROAD FUND, ONE THIRD FROM THE NOXIOUS WEED FUND, AND THE OTHER THIRD COMING FROM THE TREE AND SHRUB FUND. MOTION CARRIED.

SOME DISCUSSION WAS MADE ABOUT THE MANOR IN WHICH THE BID WAS TAKEN IN PERTAINING TO THE CEMETERY CLEAN-UP. NO ACTION WAS TAKEN.

MOTION WAS MADE BY COUNCILMAN HANSBAUGH AND SECONDED BY COUNCILMAN BROWN THAT THE FUND ADJUSTMENT BE MADE PERTAINING TO THE DUMP TRUCK PURCHASED FROM DAN STANIEY. THE MONEY FORETHEOTRUCK TO BE TAKEN FROM THE SPECIAL HIGHWAY FUND RATHER THAN THE REVENUE SHARING. MOTION CARRIED.

A LETTER FROM A CPA FIRM BRADIEY BAIL WAS READ EXPLAINING THE TRANSFER TO BE IN ORDER.
