Mayor Bankson presented the name of Mary L. Taylor for Relief Dispatcher. Moved by Little, seconded by J. Watkins, to approve the Mayor's recommendation to hire Mary L. Taylor as Relief Dispatcher. Motion declared carried.

Moved by Little, seconded by J. Watkins, to approve the rezoning of the Williams-Capps property in Empire from R-1 to Agricultural.

Motion declared carried.

Moved by J. Watkins, seconded by Little, to close Wall Street between 7th & 8th in the evenings, to provide parking during Galena Days. Police Chief Lyerla conferred with Mr. O's and the Senior Citizens and was told it would not be a problem for them. Motion declared carried.

Councilmember Little discussed the need to reroute the Galena Day Parade because of the building being torn down at 3rd & Main. The parade will begin at 11th Street and turn West at 4th Street to end.

Councilmember Little discussed sending the patrolman without Police School to a school in Parsons starting Monday for 1 week. This would be all that is required since he has completed the Missouri Police Academy.
