MINUTES:

Moved by ROGERS, seconded by TIPTON to approve and place on file the minutes of the Regular Council Meeting of June 20. 1995 AYES: TIPTON, PRICE. DAVIS, BURKYBILE, ALLEN, REYNOLDS. WARD. bу ROGERS NAYS: NONE Motion declared carried.

FIREMEN'S RELIEF ASSOC:

Moved by DAVIS. seconded by PRICE to place on file the minutes of the Firemen's Relief Association Meeting of June 22. 1995.

SEWER. 11TH & BELLEVUE:

Superintendent Sills informed the council that Dart Construction is constructing two new homes at 11th & Bellevue. Sewer is not available to the structures. It would be necessary to install about one block of sewer line to accomodate these structure.

Moved by BURKYBILE. seconded by WARD to install the necessary sewer line for these two new Structures. AYES: TIPTON, PRICE DAVIS. BURKYBILE, ALLEN, REYNOLDS, WARD; ROGERS NONE Motion declared carried.

CHASTAIN SEPTIC TANK:

Superintendent Sills informed the council that Ben Chastain is placing a modular home on property at the Northeast Corner of Columbus and Forest. Sewer is not available to this structure. Mr. Chastain requests he be allowed to install a septic tank.

Moved by BURKYBILE, seconded by PRICE to allow Ben Chastain to install a septic tank on this property.

DOZER REPAIR:

Superintendent Sills discussed with the council the repair of the

Allis Chalmers dozer. Cost is approximately \$3000.

Moved by BURKYBILE. seconded by DAVIS to approve the repair of the dozer at a cost of \$3000 to be paid from the Landfill Fund.

STREET SWEEPER REPAIR:

Superintendent Sills informed the council the engine is blown in the Street Sweeper. Cost for a new motor is \$2970. Cost to repair the old motor was approximately the same.

Mayor Oglesby reminded the council that the city was given funds for maintenance of this sweeper of Mid West Environmental.

Moved by WARD, seconded by BURKYBILE to make the necessary repairs on the street sweeper and to pay for these repairs from the Special Highway Fund, AYES: TIPTON, PRICE, DAVIS, BURKYBILE, ALLEN, REYNOLDS, WARD, ROGERS NAYS: NONE Motion declared carried.

SEK SOLID WASTE COMM TIPPING FEE: A copy of the letter recived from the SEK Solid Waste Commission informing the city this commission had been formed and included nine Southeast Kansas Counties. It also informed the council that an assessment of 25 cents per ton on all solid waste accepted by landfills. This assessment would begin July 1, 1995.

Superintendent Sills informed the council that effective July 1, the Kansas Department of Health & Environment is lowering its tipping fee from \$1.50 to \$1.00 per ton. This was done by the legislature.

The council discussed whether this commission can assess a fee for solid waste.

Moved by BURKYBILE, seconded by ROGERS for the city not to pay this assessment.

Motion declared carried.

Mayor Oglesby informed the council that he is not in favor of paying the fee either.

BASE ROCK, CITY PARKS:

Burkybile informed the council that base rock is needed for the area along Shoal Creek at Schermerhorn Park and on the roads in the parks.

Allen said he is opposed to putting any more base rock in the area along Shoal Creek and in the creek bed due to the flooding.

Ben Biddle, park caretaker said he has dozed out the creek bed and this base rock is not necessary at this time.

No action taken.

WHISTLE, 21ST & WOOD:

Tipton informed the council that the Street Committee met at 21st & Wood to view the problem with the whistle. Verlyn White, surveyor. met with the committee and was to provide the costs for changing this whistle.

Superintendent Sills said Mr. White shot the area yesterday. He said Mr. White said the creek does not cause the flooding in the basement of the house on this corner. Superintendent Sills has not received the information from Mr. White on the costs.

This item was tabled until the next meeting.

ROOFS AT SCHERMERHORN:

Davis informed the council that Ben Biddle. park caretaker. has informed her that the roofs at the pavillion, the scout cabin and the garage used to store the city equipment is leaking badly. She asked what can be done until it is determined whether the city can obtain grant funds for the repair or replacement of these structures.

Moved by BURKYBILE. seconded by REYNOLDS that the city crew repair the roof on the pavillion as best they can until it is determined whether the city will receive grant funds.

This item is tabled until the next meeting.

DRUG FREE WORKPLACE:

Allen recommended the city adopt a Drug Free Workplace policy providing for the drug testing currently being done for new employees and to do a random sampling once each year on employees and employees be given a drug test at the recommendation of their supervisor.

Price said she is not against the testing but thinks all employees should be included in the random sampling at sometime during the year.

Moved by ROGERS. seconded by BURKYBILE for the Personnel Committee to draft a proposal for a Drug Free Workplace.

TRAFFIC LIGHT 7TH & MAIN:

Kansas Department of Transportation providing for a new traffic light at 7th & Main Streets was included in the council packets. Cost for the lights would be \$70,000 with the city being required to pay 10% of the cost. copy of the letter from the

KMIT SAFETY COMMITTEE:

Mayor Oglesby informed the council that KMIT. the city's workers compensation carrier, recommends a safety committee be formed.

Chief Hentz informed the council that he had attended the meeting concerning the forming of this committee and he will obtain copies of other city's policies concerning this.

Moved by ROGERS, seconded by BURKYBILE to form a Safety Committee with Chief Hentz to be the coordinator.

WIC PROGRAM:

Mayor Oglesby informed the council that effective July 1. the area used by the WIC program must be smoke free during the time they are using it. This is a Federal requirement.

The council discussed having the City Hall Building smoke free.

Moved by PRICE, seconded by DAVIS to place Non Smoking signs in the hall while the WIC Program is using the building.

HEALTH INSURANCE:

The council discussed the cost of health insurance coverage for the city employees and their families. The proposals received for the June 20 meeting had been reviewed by the council members.

John Beran, a representative from Blue Cross Blue Shield of Kansas. the city's current carrier was present to answer any questions.

The council discussed whether the city could continue to pay the full premium for the coverage.

LIFEGUARDS:

Mayor Oglesby informed the council that two of the lifeguards had quit at the city pool. This leaves only two liefguards including the pool manager. The city clerk has contacted other cities to obtain lifeguards. but all are having the same problem.

CITY WIDE GARAGE SALE:

Mayor Oglesby informed the council that the Chamber of Commerce has scheduled the annual City Wide Garage Sale for August 5. 1995. They would like permission to block Main Street for a fleamarket to allow the permits to be sold from the city clerk's office and for the city to not allow regular garage sale permits to be

sold for this one day.
