The City Council of Galena, Kansas, met in special session July 27, 1970, at 8 o'clock at the city building in the council-room.

BE IT RESOLVED by the Governing Body of the City of Galena, Kansas, that the Southern Standard Plumbing Code, 1967 Edition, with revisions through 1970 and all future revisions be adopted to replace the American Standard National Plumbing Code 1965 Edition A40.8.

Councilman Pittman moved, seconded by Councilman Tackett, that the foregoing resolution numbered 70-4 be placed on roll call vote for adoption. Mayor Dillon reconvened the meeting and Matt Mense, Barrett and Cusack, presented the proposed 1971 Budget. Mr. Mense asked for suggestions and answered questions regarding the tax levy.

Councilman Pittman moved, seconded by Councilman Bogle, that the tax levy be increased by 1.13 by roll call vote. On roll call the vote was as follows: Yeas - Councilmen Pittman, Noe, and Bogle, Nays - Councilmen Watkins, Tackett, and Brown. Mayor Dillon declared the motion lost.

Councilman Pittman moved, seconded by Councilman Noe, that the hearing for the budget be on the 11th day of August, 1970, at 7 o'clock, in the council-room at the city building. On roll call the vote was as follows: Councilmen Pittman, Tackett, Bogle, Brown, Noe, and Watkins; Nays - none. Carried.

Councilman Noe moved, seconded by Councilman Pittman, that the meeting be adjourned. Motion carried on a standing vote.
