7-101 Fire Department will have Chief, 2 Assistant Chiefs and City and Rural Fire Captains.

7-104 Assistant Fire Chief--In the absence of the chief, the assistant chief, and the captains shall perform all the duties and have all the authority and responsibility of the chief, in accordance with their ranks in the chain of command as conferred by this article.

12-103 Grave opening charges: Under 5 feet, \$90 and infant graves free.

Setting off a new section in Hill Crest and Oak Hill for infant graves was discussed.

12-107 After Federal Deposit Insurance Corporation, add "and pledging"

12-115 Foot stones: (a) All the current foot stones will not be driven down or reinstalled at surface level. Any new section of the cemetery opened will have head and foot stones at surface level.

15-109 (a) Leaks will be adjusted according to the following formula:

Customer pays 3 month average of water charge plus \$10 of the water charge. Balance of water charge divided equally between customer and city.

15-109 (b) No adjustment made on water charges less than \$10 above the average bill.

15-108 Delete "or off" and add after authorized city employee has turned it off.

13-205 (c) If utility companies or contractors resurface streets or sidewalks, they must be completed in 30 working days, weather permitting.
