MINUTES OF SPECIAL COUNCIL MEETING, SEPTEMBER 27, 1979

THE GOVERNING BODY OF THE CITY OF GALENA MET IN SPECIAL SESSION THURSDAY EVENING, SEPTEMBER 27, WITH MAYOR L. G. WILLIAMS, PRESIDING.

COUNCIL MEMBERS PRESENT WERE: SMITH, FAULKNER, PIERCEFIELD, CURE,

COUNCIL MEMBERS ABSENT WERE: HOPKINS, DAVIES AND BAILEY

MAYOR WILLIAMS ANNOUNCED THE PURPOSE OF THE MEETING, WHICH WAS TO CONSIDER AN APPLICATION FOR SMALL CITIES FUNDING, AS PRESENTED BY MRS. MARSHA EBAUGH OF WICHITA.

MRS. EBAUGH EXPLAINED THE VARIOUS PURPOSES THE FUNDS COULD BE USED FOR AND THE THREE OPTIONS AVAILABLE. SHE RECOMMENDED THE CITY APPLY FOR A ONE YEAR COMPREHENSIVE PROGRAM IN WHICH SEVERAL ACTIVITIES, ALL OF WHICH RELATE TO EACH OTHER, ARE CARRIED OUT IN A DESIGNATED AREA.

MRS. FAULKNER MOVED TO ALLOW MRS. EBAUGH TO SUBMIT AN APPLICATION, ASKING \$460,000. FUNDING. PIERCEFIELD SECONDED THE MOTION, AND THE MOTION CARRIED.
