A SPECIAL MEETING WAS HELD TO DETERMINE THE REASON AS TO WHY EMPIRE WAS DELETED ON WATER MAIN IMPROVEMENTS.

MR. HAROLD BERNSTEIN, REPRESENTING THE HUD OFFICE IN KANSAS CITY, EXPLAINED THAT A WELL BALANCED PROGRAM WAS REQUIRED AND THAT ANY CHANGES TO BE MADE WOULD HAVE TO COME FIRST FROM THE CITY GOVERNMENT BODY.

IT WAS DISCOVERED AT THE MEETING THAT SOME OF THE WATER MAINS WERE LOCATED OUTSIDE THE PROJECT AREA, AND THAT HUD MONEY COULD NOT BE USED FOR THESE LINES.

COUNCILMAN BOGLE WAS VERY PERSISTENT THAT EMPIRE BE CONSIDERED FOR WATER MAINS. C. B. SIMMONS, RESIDENT ENGINEER, EXPLAINED THAT ANY DELETIONS OR ADDITIONS TO THE PROJECT WOULD BE AS DISCRETION OF THE CITY COUNCIL. HE FURTHER EXPLAINED THAT HE WOULD WORK WITH THEM AND SUBMIT ANY RECOMMENDATIONS TO THE HUD OFFICE.

THE NINE COUNCILMEN PRESENT, STUDIED THE MAPS AND MADE SUGGESTIONS AS TO CHANGES THAT WOULD BE NECESSARY.
