ROLL CALL:

INTERIM CITY MANAGER:

Motion made by Brandenburg, seconded by Jackson to appoint Debbie Kitch as Interim City Manager. Motion declared carried.

Mayor LaTurner stated we would start advertising for a city manager but would wait till the two new commission members came aboard before hiring one.

CITY MANAGER:

Mike Tash stated he would like to address the commission on his view of what happened Monday night. He stated he had been working with Mr. Nice on several occasions and new Mr. Nice had sent many letters out on the clean-up, but once they went into the court system his hands were tied. He asked if the decision was made for the lost of his job on the apparent lack of letters going out.

The commission stated this was not the reason.

Mr. Tash questioned again if it was based on the clean-up and if not if the commission could discuss why Mr. Nice was no longer with the city.

Mayor LaTurner stated just as his employer would not speak about him he could not go into that. Mayor LaTurner stated it was nice for someone to come out and say something positive about one of our employees.

Mr. Tash apologized for not coming to the meetings and saying what a good job Mr. Nice was doing or Debbie or whoever. He asked if anything had been done to find out the opposite side of it, the appearance of it was like it was ramrod through and is a shock to the community. He asked if it was isolated to five or six people.

Commissioner Brandenburg stated he had a lot of calls from the people in the community. He stated he had complaints the people at large were not happy.

Commissioner Jackson advised the discussion needed to slow down, and the agreement was the city manager would give them his resignation for x dollars with the agreement they would give him a good recommendation
