

MINUTES OF
SPECIAL COUNCIL MEETING
NOVEMBER 23, 1993

CALL TO ORDER:

The Special Meeting of the Galena City Council was called to order Tuesday, November 23, 1993 at 7:00 p.m. in the Council Chambers with Dale Oglesby, Mayor, presiding. Purpose of the special meeting was to discuss personnel. Each council member received notice of the meeting by personal delivery by the Galena Police Department.

ROLL CALL:

Roll call indicated the following council members present: GABRIELSON, HAYES, HARPER, SCOTT, BURKYBILE, BYRD, ALLEN, ADAMS, WARD, ROGERS
ABSENT: NONE

PETITION:

Burkybile presented a copy of a blank petition to Mayor Oglesby. She informed the council that someone had given her the copies at 5:00 p.m. this evening. She said she had a copy of the names but did not have the original petition. She stated she did not know who had passed the petition.

Lillian Price stated there were 220 names on one petition and 214 on the second.

ADJOURNMENT:

Moved by ROGERS to adjourn the Special Meeting of the Galena City Council.

Motion died for lack of second.

PETITION:

Burkybile read the heading at the top of the petitions. One requested the resignation of Mayor Dale Oglesby and the other requested the resignation of the Acting Chief, Bob Lawrence.

Moved by ALLEN, seconded by BYRD to accept the petitions and place them on file.

NAYS: ROGERS, HARPER

It was stated that Councilman Scott had the original petitions. He was requested to turn in the petitions to be placed on file.

Lillian Price stated to the council that the persons signing the petitions did not want them turned in to the Mayor. She stated the people are afraid of reprimands.

Burkybile stated the Mayor has copies of what is on the petition.

Allen asked about the validity of the signatures.

Lillian Price stated the petitions will be verified.

Mayor Oglesby asked who had been threatened.

Lonnie Boyd stated Bob Lawrence had told him he was going to run him out of town.

Bob Lawrence stated that was not true. He said Mr. Boyd was upset because he had been stopped for illegal tags on more than one

Boyd stated he had only been stopped once.

Mr. Boyd asked Bob Ferguson to come into the council room.

Mr. Ferguson asked why the police cars were being driven outside the city limits and being used as security for Midwest.

Mr. Lawrence stated this was with the approval of the Mayor.

Mayor Oglesby stated he had approved this.

Ruby Jenkins stated where there's smoke there must be fire.

Clyde Coleman stated this was a witch hunt. He asked where some of the residents are that were harassed.

Ruby Jenkins asked by Flora Stansberry, who is not on the council, was allowed to work on the water project.
