

MINUTES OF
GALENA CITY COUNCIL MEETING
DECEMBER 28, 1984

CALL TO ORDER:

The Special Meeting of the City Council of the City of Galena, for the purpose of approving cereal malt beverage license, 590 Galena Occupational License, Salary Increase Ordinance, Payroll, and Water Department employee, was called to order by Mayor Pro Tem, Neal Little at 7:02 P.M. in the Council Chambers, on Friday December 28, 1984.

CEREAL MALT BEVERAGE
LICENSE:

Moved by Anderson, seconded by King, to issue Cereal Malt Beverage License to Marie Hardwick- Hardwick's Grocery for Carry Out and to David Shallenburger - Walton's Service Station for Carry out. Motion declared carried.

509 GALENA AVE.
OCC. LICENSE:

Moved by Allen, seconded by King, not to issue a 1985 Occupational License to Bob's Auto Repair and Body Shop at 509 Galena Avenue as was previously recommended by the Planning & Zoning Commission. Motion declared carried.

SALARY INCREASE
ORDINANCE #84-26:

Moved by Anderson, seconded by Bullard, to approve the Salary Increase Ordinance #84-26 after amending the Mechanics pay to be the same as the Operators pay. Motion declared carried.

Moved by J. Watkins, seconded by King, that the Mechanic-Carpenter's pay be the same as Operators which is \$5.16 per hour. Motion declared carried.

LAY OFF TEMPORARY
HELP:

Supt. Howard Jarvis recommended that two of the temporary employees, Lloyd Cockrell and William Messer be laid off. He informed the council that Richard Scofield had already quit.

HIRE WATER EMPLOYEE:



Moved by Anderson, seconded by King, that Payroll 84-29 in the amount of \$7,391.48 be approved. Motion declared carried.
