

MINUTES OF CITY
SPECIAL COMMISSION MEETING
FEBRUARY 22, 2005

CALL TO ORDER:

The Special Meeting of the Galena City Commission was called to order on Tuesday, February 22nd at 6:00 p.m. in the commission chambers with Mayor Protem Marion Davies presiding.

ROLL CALL:

Roll call indicated the following commissioners **present:** HARDMAN; SHOEMAKER; DAVIES; OGLESBY; **absent:** DONALDSON

WALTER BRADSHAW
REDRISTRICK MAP:

Mr. Bradshaw approached the commission in regard to Commissioner Oglesby's letter in the Galena Sentinel. He stated the map he received from county was not broken down by register voters and he wanted the commission to know he took Sandy Soper everything that was done by the committee, which she stated she saw nothing wrong. He noted that nothing was done behind closed doors, and wanted them to know that it was the Change of Government Committee that had done the redistrict map; the concerned citizens group had nothing to do with it.

Commissioner Oglesby asked if Mr. Bradshaw would like a response. If he was telling him he basically had received bad information from the county, and redistricting of the map was based on information they gave him and the information changed he absolutely accepts that and does not have a problem with it. He said this was not an attack, that the fact was they were told by the committee that it was in this real tight guideline.

Mr. Bradshaw Bradshaw stated it was population not registered voters, and the population was well with in the 5 percent margin that was required by state law.
