Moved by Mr. Nichols; seconded by Mr. Watkins to pass Ordinance 13-3 rezoning from current designations including R-1 zoning to an R-3 zoning designation, as applicable, said property being legally described as follows, with said legal description to control over any inconsistency with any in formal description herein: A part of the Government Lot 4 in the SE1/4 of Section 13, Township 34 South, Range 25 East, Cherokee County, KS, more particularly described as follows: Beginning at a point on the East line of said Lot 4 that is 460 feet North of the SE Corner thereof, thence W 436 feet, thence N 200 feet, thence W 24 feet, thence N 186 feet, thence E 460 feet to a point on the East line of said Lot 4, thence S 386 feet to the point of beginning, Less highway right-of-way:


