The council recommended to start a condemnation timeline since Mrs. Rowden has been granted two 30 day extensions with no noticeable results. Code Enforcement Officer J.J. Dannels was asked about the property and he presented the council with pictures showing the problems with the house. It was also suggested that the water line be disconnected & the sewer line capped to prevent any damage during the demolition.
