



RESOLUTION NO. 96-3

A RESOLUTION ASSURING THE CONTRIBUTION OF CITY FUNDS FOR A
PROPOSED COMMUNITY IMPROVEMENT PROJECT UNDER THE
1996 SMALL CITIES COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM

WHEREAS, The City of Galena is applying for a Small Cities Community Development Block Grant (CDBG) funds under the Community Improvement category as administered by the Kansas Department of Commerce and Housing; and,

WHEREAS, The City of Galena wishes to utilize this funding for the purpose of Sanitary Sewer System Improvements as described in the Community Development Block Grant application submitted to the Kansas Department of Commerce and Housing.

NOW, THEREFORE, BE IT RESOLVED THAT: The Governing Body of the City of Galena, Kansas, hereby obligates \$110,000.00 in the form of Revenue Bonds with \$10,000.00 of these funds being placed in an escrow account, as the City's share to be used for Sanitary Sewer System Improvements, contingent upon Community Development Block Grant funding from the Kansas Department of Commerce and Housing.

A RESOLUTION ASSURING AND CERTIFYING TO
THE KANSAS DEPARTMENT OF COMMERCE AND HOUSING THAT
THE CITY OF GALENA POSSESSES LEGAL AUTHORITY TO SUBMIT A GRANT APPLICATION,
TO RECEIVE GRANT FUNDS, AND HEREBY AUTHORIZES THE MAYOR AND CITY CLERK

WHEREAS, The City of Galena has the legal authority to apply for, receive and administer federal, state and other grants and loans through its Home Rule Power under Article 12-5 of the Constitution of the State of Kansas and through Statute 12-1662, relative to expenditure of federal funds; and

WHEREAS, The City of Galena is desirous of applying for U.S. Department of Commerce, Housing and Urban Development Small Cities Community Development Block Grant (CDBG) funding through the Kansas Department of Commerce and Housing for the purpose of obtaining a Community Improvement Grant for Sanitary Sewer System Improvements as delineated in the Community Development Block Grant application.


NOW, THEREFORE, BE IT RESOLVED THAT: The Governing Body does hereby authorize the Mayor and City Clerk to act as the official representatives of the grantee and to sign and submit the application, to provide such additional information as may be required, and act as official representatives of the City of Galena in this and subsequent matters.

RESOLUTION NO. 96-5

A RESOLUTION ASSURING THE KANSAS DEPARTMENT OF COMMERCE AND HOUSING THAT FUNDS WILL BE CONTINUALLY PROVIDED FOR THE OPERATION AND MAINTENANCE OF THE SANITARY SEWER SYSTEM IMPROVEMENTS PROJECT TO BE FINANCED IN PART BY COMMUNITY DEVELOPMENT BLOCK GRANT FUNDS AS DELINEATED IN THE 1996 COMMUNITY DEVELOPMENT BLOCK GRANT APPLICATION.

WHEREAS, The City of Galena is desirous of applying for U.S. Department of Housing and Urban Development Small Cities Community Development Block Grant funds under the Community Improvement category that are administered by the Kansas Department of Commerce and Housing; and

WHEREAS, The City of Galena has reviewed operation and maintenance costs and thus estimated its annual cost to operate and maintain the Sanitary Sewer System to be \$ 130,000.00 and has further determined that an annual allocation of \$ 130,000.00 will be sufficient to provide for the continual operation and maintenance of the proposed sanitary sewer system improvements.


NOW, THEREFORE, BE IT RESOLVED THAT: The Governing Body of the City of Galena, Kansas, hereby assures the Kansas Department of Commerce and Housing that it will annually allocate \$ 130,000.00 for the continued long-range operation and maintenance for the Sanitary Sewer System which include improvements delineated in the 1996 Community Development Block Grant Application, and that these costs will be reviewed annually, and that the Sewer Budget, will be adjusted, if necessary, to reflect and cover any increase in costs.





A RESOLUTION TO MEET THE CIVIL RIGHTS OBLIGATIONS OF THE KANSAS DEPARTMENT OF COMMERCE & HOUSING (KDOC&H), COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROGRAM WHICH WILL FURTHER FAIR HOUSING OPPORTUNITIES IN GALENA, KANSAS.


WHEREAS, in order to comply with the Civil Rights requirements set forth by KDOC&H, CDBG Program, the City of Galena does hereby adopt and support the Kansas Act Against Discrimination and the Fair Housing Amendments Act of 1988; and

WHEREAS, the Kansas Act Against Discrimination (K.S.A. 44-1001 to 44-1121) was passed in 1953 which prohibits discriminatory employment practices in places or public accommodations because of race, religion, color, national origin or ancestry; and

WHEREAS, the Fair Housing Act as amended was enacted on October 13, 1988 by the United States of America to provide, within constitutional limitations, for fair housing throughout the United States. Any person regardless of race, color, religion, sex, handicap, familial status, or national origin is afforded the equal right to occupy, purchase, sale or rent a dwelling when such a dwelling is in fact so available.


NOW, THEREFORE, BE IT RESOLVED THAT; The Governing Body of the City of Galena does hereby support the Kansas Act Against Discrimination and the Fair Housing Act and will provide copies of the acts to any interested citizen by contacting the Galena City Clerk.

WHEREAS, the City of Galena, Kansas recognizes the need for affordable housing within the Galena City limits, the City of Galena hereby resolves the following:


