RESOLUTION NO. 2618

A RESOLUTION AUTHORIZING THE TEMPORARY CLOSURE OF A PORTION OF 4TH STREET AND THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES DURING A DESIGNATED SPECIAL EVENT WITHIN THE CITY OF GALENA, KANSAS

WHEREAS, the City of Galena, Kansas, is a municipal corporation organized and existing under the laws of the State of Kansas; and

WHEREAS, the Governing Body of the City of Galena finds that community events promote economic development, tourism, and civic engagement; and

WHEREAS, Gravy's Place has requested permission to conduct a special event that includes the temporary closure of a public street and the sale and consumption of alcoholic beverages within a designated area; and

WHEREAS, the Governing Body finds it necessary to ensure that such activities are conducted in a safe and controlled manner consistent with applicable Kansas laws and city ordinances;

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF GALENA, KANSAS:

SECTION 1. STREET CLOSURE AUTHORIZED

The City hereby authorizes the temporary closure of 4th Street from Short Street to Main Street

on the date(s): June 5th, 2026
during the hours of: 4:00pm to 11:59pm

The City may require barricades, signage, and traffic control measures as deemed necessary by the City or its designee.

SECTION 2. AUTHORIZATION FOR SALE AND CONSUMPTION OF ALCOHOL

Gravy's Place is hereby authorized to sell and allow the consumption of alcoholic beverages within the designated event area during the approved event times, subject to the following conditions:

1. All applicable Kansas state laws and local ordinances regarding the sale and consumption of alcohol must be followed.
2. Alcohol consumption shall be limited to the designated, controlled event area on **4th Street from Short Street to Main Street.**
3. No alcoholic beverages shall be removed from the approved event boundary.
4. Proper identification shall be required for all alcohol sales.
5. The license holder shall maintain all required state and local permits.

SECTION 3. SECURITY AND SAFETY REQUIREMENTS

Gravy's Place shall be responsible for:

- Providing adequate security personnel as required by the City or Police Department
- Maintaining order within the event area
- Ensuring compliance with all applicable laws
- Providing trash receptacles and post-event cleanup
- Coordinating with emergency services if necessary

SECTION 4. INSURANCE AND LIABILITY

Gravy's Place shall provide proof of liability insurance, naming the City of Galena, Kansas, as an additional insured, in an amount acceptable to the City.

The event organizer agrees to indemnify and hold harmless the City, its officers, employees, and agents from any and all claims, damages, or liabilities arising from the event.

SECTION 5. REVOCATION

The City reserves the right to revoke this authorization at any time if conditions of this resolution are not met or if public safety concerns arise.

SECTION 6. EFFECTIVE DATE

This Resolution shall take effect and be in full force from and after its adoption by the Governing Body of the City of Galena, Kansas.
