ORDINANCE NO. 24-06

Be it ordained by the Governing Body of the City of Galena, Kansas.

Section 1. Article 2 and 3 of Chapter 15 of the Code of the City of Galena is hereby established to add the following section to read as follows and Ordinance 2006-05 is hereby repealed:

SECTION 1. The following fee schedule shall be established:

Fee Payment. All fees specified below shall be paid at the time of the application, unless otherwise specified.

Zoning application. In the regard to the property sought to be zoned or rezoned the application fee shall be \$250.00. From these proceeds the city shall pay any publication and postage costs associated with the application.

Conditional Use and Variances. In regard to the property for which a conditional use or variance is sought the application fee shall be \$250.00. From these proceeds the city shall pay any publication and postage costs associated with the application.

Subdivision fees. In regard to the property for which approval of a subdivision plat is requested from the city the application fee shall be \$325.00. From these proceeds the city shall pay any publication and postage costs associated with the application.

Vacating of streets or alley - applications. The fee for an application to vacate a street or alley shall be \$250.00. From these proceeds the city shall pay any publication and postage costs associated with the application.

Water Tap Fees. Any request for a water tap from the city shall be paid according to the following schedule plus actual cost before any connection is undertaken:

Tap Size - inches	Inside the City Limits	Outside the City Limits
1 or less	\$500.00	\$750.00
more than 1 but not more than 2	\$2500.00	\$3125.00
more than 2 but not more than 4	\$4000.00	\$5000.00
more than 4 but not more than 6	\$6500.00	\$8125.00

The city reserves the right to not supply a water tap to anyone outside the city limits.

Sewer Tap Fees. Any request for sewer taps from a 4-inch or 6-inch private line to a city 8-inch or larger main sewer line shall be \$600.00 plus actual cost and shall be paid before any connection is undertaken. The city reserves the right to not supply a sewer tap to anyone outside the city limits.

Activating Water Service. The fee for an application to activate water service shall be \$75.00.

Cemetery Lots. The fee for the purchase from the city of a cemetery lot shall be \$200.00. The grave opening fee for Monday through Friday shall be \$300.00. On Saturday the grave opening fee shall be \$375.00.


Utility repairs. In the event any of the above utility installations causes damage to the street, sidewalk, or curb and guttering, an additional repair fee of actual cost shall be assessed.

SECTION 2. Any provisions in prior enacted ordinances that establish a different fee for the services herein described are repealed.

SECTION 3. This Ordinance shall take effect and be in full force upon its publication once in the official city newspaper.
