ORDINANCE NO. 07-05

AN ORDINANCE REGULATING THE OPERATION OF TRUCKS KNOWN AS TRACTOR-TRAILER RIGS OR EIGHTEEN WHEELERS IN THE CITY OF GALENA, KANSAS, AND SETTING FORTH ROUTES FOR SUCH VEHICLES.

BE IT ORDAINED BY THE GOVERNING BODY OF GALENA, KANSAS, THAT:

Section 1. This ordinance is applicable only to those trucks known as Tractor-trailer rigs or eighteen wheelers.

Section 2. The following is hereby designated as a truck route for the use of the above described vehicles in the City of Galena, as follows: Commencing at the intersection of Main Street and Clark Street, then along Clark Street eastward to the intersection of Clark Street and Old Highway 66, then eastward along Old Highway 66 to Stateline Road, then southward along Stateline Road to the intersection of Stateline Road and Seventh Street, then southward along Stateline Road to the intersection of 11th Street extended eastward and Stateline Road. All of Seventh Street and Highway 26 constitute truck routes.

Section 3. It shall be a violation of this ordinance for any of the above described vehicles to be operated on any street in the City of Galena, Kansas, that is not a designated truck route, except when said vehicles are making a pick-up or delivery of freight or merchandise in areas within the city not accessible solely by travel along a designated truck route and such vehicles are on the most direct route between a designated truck route and the place of pick-up or delivery.

Section 4. Any person convicted of a violation of this ordinance shall be guilty of the offense of Failure to Follow a Truck Route and upon such conviction shall be subject to a fine of not less than \$50.00 nor more than \$250.00.

Section 5. Ordinance No. 06-03 that established Main Street as a truck route is hereby repealed.



Section 3. It shall be a violation of this ordinance for any of the above described vehicles to be operated on any street in the City of Galena, Kansas, that is not a designated truck route, except when said vehicles are making a pick-up or delivery of freight or merchandise in areas within the city not accessible solely by travel along a designated truck route and such vehicles are on the most direct route between a designated truck route and the place of pick-up or delivery.

Section 4. Any person convicted of a violation of this ordinance shall be guilty of the offense of Failure to Follow a Truck Route and upon such conviction shall be subject to a fine of not less than \$50.00 nor more than \$250.00.

Section 5. Ordinance No. 06-03 that established Main street as a truck route is hereby repealed.
