ORDINANCE NO. 13-5

AN ORDINANCE ENACTING THAT CERTAIN CODE KNOWN
AS THE "STANDARD TRAFFIC ORDINANCE FOR KANSAS CITIES,
EDITION OF 2013."

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY
OF GALENA, KANSAS that:

Section 1. Article 1 of Chapter 14 of the Code of the City of Galena
is hereby amended to add the following section to read as follows:

14-101. INCORPORATING STANDARD TRAFFIC ORDINANCE.
There is hereby incorporated by reference for the purpose of regulating
traffic within the corporate limits of the City of Galena, Kansas, that certain
code known as the "Standard Traffic Ordinance for Kansas Cities, Edition
of 2013," prepared and published in book form by the League of Kansas
Municipalities, Topeka, Kansas, save and except such articles, sections,
parts or portions as are hereafter omitted, deleted, modified or changed.
No fewer than three copies of said Standard Traffic Ordinance shall be
marked or stamped "Official Copy as Incorporated by the Code of the City
of Galena, Kansas," with all sections or portions thereof intended to be
omitted or changed clearly marked to show any such omission or change
and to which shall be attached a copy of this section, and filed with the city
clerk to be open to inspection and available to the public at all reasonable
hours. (Code 2013, Ordinance 13-5)

Section 2. This ordinance shall take effect upon publication in the
official city newspaper.

Section 3. The provisions of Ordinance 12-7 are hereby repealed.

ORDINANCE NO. 13-5

AN ORDINANCE VACATING CERTAIN PORTIONS OF JOPLIN STREET BETWEEN FOREST STREET AND WALNUT STREET.

BE IT ORDAINED BY THE GOVERNING BODY OF GALENA, KANSAS, THAT:

Section 1. A portion of the platted street known as Joplin Street between Forest Street and Walnut Street, according to the recorded plat thereof, that is legally described as

“That portion of Joplin Street that is adjacent to Lots 16 and 17 in Empire City, now a part of the City of Galena, Kansas, according to the recorded plat thereof,” is hereby vacated and such vacation is hereby deemed necessary or expedient.

The city council hereby deems this action taken pursuant K.S.A. 14-423 and on the City Council’s own motion this action is taken pursuant to K.S.A. 14-423, and any amendments thereto.

Section 2. The City reserves for the City the rights for public utilities, rights-of-ways, and easements for public service facilities in existence and use.

Section 3. This ordinance shall take effect thirty (30) days after publication in the official city newspaper unless a written protest is filed in the office of the city clerk before the expiration of such time.
