

ORDINANCE NO. 85-7

AN ORDINANCE FIXING COMPENSATION FOR THE EMPLOYEES OF THE CITY OF GALENA, AND REPEALING ORDINANCE 84-26.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF GALENA:

SECTION 1: That employees of the City of Galena, shall receive as full compensation for their services as such employees, the following amounts to-wit:

SECTION 2: That the above set longevity increase shall be added for each year of service up to a maximum of five (5) years, beginning with their first pay period following their anniversary date.

SECTION 3: That the compensation provided for in this ordinance shall become effective January 1, 1986.

SECTION 4: Probational employees will be paid at a rate of 25¢ per hour less than ordinance rate, until they have worked 90 days, EXCEPT in the condition of it being an employee that is reappointed at the annual time. Part-Time salaried employees will be hired on a 90 day probationary period like other employees, but will be paid regular ordinance pay - not probationary pay.

SECTION 5: Ordinance Number 84-26 is hereby repealed in its entirety, effective midnight December 31, 1985.

SECTION 6: This Ordinance shall take effect and be in full force from and after its publication in the official City paper, the Galena Sentinel-Times and commencing with the first pay period for 1986.
