AN ORDINANCE FIXING COMPENSATION FOR THE EMPLOYEES OF THE CITY OF GALENA, KANSAS, REPEALING ORDINANCE 87-1 IN ITS ENTIRETY, AND AMENDING SECTION 5 OF ORDINANCE 86-8.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF GALENA:

SECTION 1: That employees of the City of Galena, shall receive as full compensation for their services as such employees, the following amounts to-wit:

SECTION 2: That the above set longevity increase shall be added for each year of service up to a maximum of five (5) years, beginning with their first pay period following their anniversary date, and excludes any employee hired after January 1, 1987.

SECTION 3: The first compensation provided for in this ordinance shall become effective January 1, 1988.

SECTION 4: Probational employees will be paid at a rate of 25¢ per hour less than ordinance rate, until they have worked 90 days, EXCEPT IN THE CONDITION OF IT BEING AN EMPLOYEE THAT IS REAPPOINTED AT THE ANNUAL TIME. Part-time salaried employees will be hired on a 90 day probationary period like other employees, but will be paid regular ordinance pay - not probationary pay.

SECTION 5: Ordinance Number 87-1 is hereby repealed in its entirety, and Ordinance Number 86-5, Section 5 is hereby amended.

SECTION 6: This Ordinance shall take effect and be in full force from and after its publication in the official City Newspaper, the Galena Sentinel-Times and commencing with the first pay period for 1988.
