BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF GALENA, KANSAS:

SECTION 1. That the following described land meeting the conditions for annexation as prescribed by K.S.A. 12-520c is hereby included and brought within the corporate limits of the City of Galena, Kansas:

Beginning at the Southwest Corner of the Northeast quarter (NE $\frac{1}{4}$ ) of Section Twenty-six (26), Township Thirty-Four (34) South, Range Twenty-Five (25) East of the Sixth Principal Meridian, thence North Three Hundred Thirty-Two (332) feet, thence East Three Hundred Sixty-Four (364) feet, thence Southwest to a point Three Hundred One and Forty Hundredths (301.40) feet due East of the place of beginning, thence West to place of beginning.

SECTION 2. This ordinance shall take effect and be in force from and after it's publication in the official newspaper, the Galena Sentinel-Times.
