

ORDINANCE 91-9

AN ORDINANCE AMENDING CHAPTER 15, ARTICLE 3, SECTION 15-306 OF THE CITY CODE OF THE CITY OF GALENA AND REPEALING ORDINANCE 91-8 IN ITS ENTIRETY, SETTING THE RATES OF COLLECTION FEES FOR SOLID WASTE.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF GALENA THAT:

SECTION 1: CHAPTER 15, ARTICLE 3, SECTION 15-306 OF THE CITY CODE OF THE CITY OF GALENA, KANSAS AND ORDINANCE 91-8 WHICH READS AS FOLLOWS:

COLLECTION FEES. Fees for the collection of refuse and garbage are as follows:

(a) Each residential unit within the city, on water and/or sewer service shall be charged at the rate of \$3.00 per month for one person or \$4.25 per month if more than one person resides at the address.

(b) All residential units outside the city, on water and/or sewer service, shall be charged at the rate of \$4.50 per month regardless of the number of persons residing at the address.

(c) The minimum charge for commercial and industrial business, listed as a water customer, shall be \$4.50 per month.

(d) Dumpster charge shall be as follows:

6 YARD	\$43.25	\$50.25	\$55.25

Refuse charges not paid shall become alien upon the real estate to which the services were furnished.

SHALL BE AMENDED AS FOLLOWS:

COLLECTION FEES. Fees for collection of refuse and garbage are as follows:

(a) Each residential unit within the city, on water and/or sewer service, shall be charged at the rate of \$3.00 per month for one person or \$4.25 per month if more than one person resides at the address.

(b) All residential units outside the city, on water and/or sewer service, shall be charged at the rate of \$4.50 per month regardless of the number of persons residing at the address.

(c) The minimum charge for commercial and industrial business, listed as a water customer, shall be \$4.50 per month.

(d) Dumpster charge shall be as follows:

Refuse charges not paid shall become a lien upon the real estate to which the services were furnished.

SECTION 2: Section 15-306 of Chapter 15, Article 3 of the

City Code of the City of Galena is hereby amended and Ordinance 91-8 is repealed in its entirety.

SECTION 3: This Ordinance shall be in full force after it approval and publication in the official city newspaper, The Galena Sentinel-Times.
