ORDINANCE 92-13

AN ORDINANCE AMENDING CHAPTER 15, ARTICLE 3, SECTION 15-306 OF THE CITY CODE OF THE CITY OF GALENA SETTING THE RATES OF COLLECTION FEES FOR SOLID WASTE AND REPEALING ORDINANCE 92-6 IN ITS ENTIRETY.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF GALENA THAT:

SECTION 1: CHAPTER 15, ARTICLE 3, SECTION 15-306 OF THE CITY CODE OF THE CITY OF GALENA, KANSAS WHICH READS AS FOLLOWS:

COLLECTION FEES. Fees for the collection of refuse and garbage are as follows:

(a) Each residential unit within the city, on water and/or sewer service shall be charged at the rate of \$5.75 per month for one person or \$8.25 per month if more than one person resides at the address.

(b) All residential units outside the city, on water and/or sewer service, shall be charged at the rate of \$8.75 per month regardless of the number of persons residing at the address.

(c) The minimum charge for commercial and industrial business, listed as a water customer, shall be \$10.00 per month.

(d) Dumpster charge shall be as follows:

Refuse charges not paid shall become a lien upon the real estate to which the services were furnished.

IS HEREBY AMENDED TO READ AS FOLLOWS:

COLLECTION FEES. Fees for collection of refuse and garbage are as follows:

(a) Each residential unit within the city, on water and/or sewer service, shall be charged at the rate of \$5.50 per month for one person or \$8.00 per month if more than one person resides at the address.

(b) All residential units outside the city, on water and/or sewer service, shall be charged at the rate of \$8.75 per month regardless of the number of persons residing at the address.

(c) The minimum charge for commercial and industrial business, listed as a water customer, shall be \$15.00 per month.

(d) Dumpster charge shall be as follows:


Refuse charges not paid shall become a lien upon the real estate to which the services were furnished.

Refuse charges not paid shall become a lien upon the real estate to which the services were furnished.

IS HEREBY AMENDED TO READ AS FOLLOWS:

COLLECTION FEES. Fees for collection of refuse and garbage are as follows:

(a) Each residential unit within the city, on water and/or sewer service, shall be charged at the rate of \$5.50 per month for one person or \$8.00 per month if more than one person resides at the address.

(b) All residential units outside the city, on water and/or sewer service, shall be charged at the rate of \$8.75 per month regardless of the number of persons residing at the address.

(c) The minimum charge for commercial and industrial business, listed as a water customer, shall be \$15.00 per month.

(d) Dumpster charge shall be as follows:


Refuse charges not paid shall become a lien upon the real estate to which the services were furnished.


SECTION 3: This Ordinance shall be in full force after it's approval and publication in the official city newspaper, The Galena Sentinel-Times.
