

## ORDINANCE 94-4

AN ORDINANCE FIXING COMPENSATION FOR THE EMPLOYEES OF THE CITY OF GALENA, KANSAS, AND REPEALING ORDINANCE 93-2 IN ITS ENTIRETY.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF GALENA:

SECTION 1: That employees of the City of Galena shall receive as full compensation for their services as such employees, the following amounts to-witt:

SECTION 2: That the above set longivity increase shall be added for each year of service up to a maximum of five (5) years, beginning with their first pay period following their anniversary date, and excludes any employee hired after January 1, 1987.

SECTION 3: Upon a change in the Federal Minimum Wage rate, all seasonal employees will be paid at the Federal Minimum Wage Rate.

SECTION 4: The first compensation provided for in this ordinance shall become effective April 15, 1994.

SECTION 5: Probational employees will be paid at a rate of \$ .25 per hour less than ordinance rate, until they have worked 90 days. Part-time salaried employees will be hired on a 90 day probationary period like other employees but will be paid regular ordinance pay, not probationary pay.


SECTION 6: Ordinance 93-2 is hereby repealed in its entirety.

SECTION 7: This Ordinance shall take effect and be in full force from and after its publication in the official city newspaper, The Galena Sentinel Times, and commencing with the pay period ending April 15, 1994.
